

**Piedmont Recreation Commission Subcommittee Report and Recommendations on
the Restriping of the Linda Beach Courts and their Future Use**

Report and recommendations made by

Commissioners Sara Ironside, Rebecca Posamentier, and Dick Carter

July 14, 2023

This provides the Piedmont Recreation Commission (“Commission”) Linda Beach Courts (“Courts”) Restriping Subcommittee’s (“Subcommittee”) report on and recommendation for restriping the Courts, as well as recommendations for the Courts’ future use.

Subcommittee and Report Objectives

The objective of the Subcommittee and this report is to make a recommendation to the Commission regarding the most appropriate restriping of the Courts upon the necessary resurfacing project to be completed in 2023/24. This restriping will determine their use as the Courts may be restriped for Pickleball only, tennis only, or both. The Commission will consider the Subcommittee's recommendations in determining its recommendation to the Piedmont City Council’s (“Council”) for its final decision/s regarding the Courts.

Additionally, the Subcommittee feels that it and the Commission have a role in recommending to the Council appropriate additional actions and parameters for the most beneficial usage of the Courts by Piedmont residents (See recommendations at conclusion.).

The Subcommittee has seriously considered the robust community feedback in the creation of the following report and the recommendations.

Background

Historical Context

The game of Pickleball was created in 1965 and made its appearance in Piedmont in about 2018. Since then it has grown in popularity both nationally and in Piedmont. Pickleball is gaining popularity because it is easy to play, low impact, and appeals to a wide range of people from kids to senior citizens. Pickleball is a lifetime sport, rapidly growing, and one of the largest activities in Piedmont for its older adult population. The activity is expanding to youth, adults, and families.

Historically, the City of Piedmont (“City”) operated 10 tennis courts at four sites. The City has had no dedicated, permanent Pickleball courts. Prior to 2019 there were no Pickleball courts available in Piedmont to accommodate the number of players who wanted to play.

In May 2018, an original Recreation Commission Pickleball and Tennis Subcommittee was formed to make recommendations to the Council regarding the play of Pickleball in Piedmont. In March 2019, the

Council approved this Subcommittee's recommendations for an 8-month trial of Pickleball play at different Piedmont courts. This trial lasted from April 2019 to November 2019.

In June 2019, the Council approved a partnership with the Piedmont Unified School District ("PUSD") to refinish the PMS Sport Courts' ("PMS Courts") surface. This was completed in August 2019. This refinishing provided lines for temporary Pickleball courts that could be set up and taken down with portable nets.

In September 2019, the Subcommittee was reactivated to review the trial. In January 2020, the City Council approved Pickleball play at the Hampton Park and Linda/Beach courts during limited, designated hours. In February 2022, an additional 30 minutes of play was added to Hampton's hours and an additional day was added at Beach.

Since that time, Pickleball's popularity has continued to grow and the demand for court time to play has continued to increase.

Current Situation Including Trial Process

The City has budgeted resurfacing and repair of the Courts, which have long been in poor condition. At the Commission meeting in September 2022 the Commission considered the establishment of a subcommittee to explore the expansion of Pickleball play at Beach Tennis Courts. In that meeting the Commission decided not to form a subcommittee to consider a trial ("Trial") of exclusive Pickleball play at the Linda/Beach courts, but rather told Piedmont Recreation staff ("Staff") it had no objection to Staff moving forward with a Trial of Pickleball play only at the Courts. The goal of the Trial is to gain a better understanding of the demand of this sport in the community and to gather data to make a recommendation about restriping them at the end of the Trial period.

Staff sent letters on January 13, 2023 informing neighbors in nearby homes of the proposed Trial 45 days prior to the Trial start date of February 27, 2023. At the request of a few neighbors, the Recreation Commission decided to reconsider the Trial and review the Trial parameters at its February 2023 meeting. Details of the Trial and parameters were considered and ultimately approved by the Commission. These parameters included times of play, opportunity for feedback via two designated Recreation Commission meetings to hear public comments, and a usage survey ("Beach Courts Pickleball Trial Survey") to better understand the interest of residents.

A press release was posted on January 31, 2023 with information about the Trial, the February 15th Commission meeting, and invited public comment. A second press release was posted on June 12, 2023 to publicize the Beach Courts Pickleball Trial Survey referenced in this report, subcommittee formation and July 19th Commission meeting. The third and final press release was issued on July 7, 2023 informing residents of the community feedback received, data collected during the trial, release of the results of the sound study and upcoming July 19th Commission meeting and the August 7th City Council meeting where the future use of the courts will be considered.

During the Trial period, the Beach Courts were converted to Pickleball play only. The court hours are 9 AM to 9 PM (or dusk, whichever comes first) all seven days of the week. Courts are locked in the evenings. Organized drop-in Pickleball play is available Monday through Friday from 10 AM to 1 PM.

The Courts are open for informal drop-in play during remaining hours. Pickleball hours at Hampton were suspended during the Trial. Pickleball play at the PMS Courts is available on Saturday and Sunday from 9 am to 5 PM.

To track usage during the Trial, a QR code that linked to a short survey asked players to check in with information about how many people were in their group, how long they intended to play, if they were a resident/non-resident, and their mode of transportation. This data is referenced throughout this report.

Staff and the Commission have reviewed a significant amount of community input regarding the Trial of dedicated Pickleball play at the Courts. Input has come in the form of emails, public comments at public meetings, player statements from Pickleball players, a petition to halt the Trial, a petition to support creating dedicated Pickleball courts, Beach Courts Pickleball Trial Survey, and a petition regarding noise concerns.

Specifically, the Commission received 330 emails and pieces of correspondence, which were reviewed closely by the Subcommittee. The Commission heard 88 public comments during five Commission public meeting agendas items throughout the span of the Trial as of July 13, 2023. In reviewing community feedback, the Subcommittee found the following common themes:

Noise	Loss of neighborhood tennis courts
Popularity of Pickleball	Gain of neighborhood Pickleball courts
Parking availability	Condition and size of courts
Dedicated courts for Pickleball	Tennis & Pickleball fees, reservations, open play, drop-in, decals
Best utilization of Beach Courts	Public process
Community building valued	Courts for Tennis & Pickleball (Mixed use)
Availability of tennis courts in City	Health benefits
Traffic conditions	Pickleball popular with older adult community

Criteria for Final Recommendation

In its April 2023 meeting, the Commission formed this Subcommittee to study the issues and make a recommendation on the Courts' restriping to the Commission, which, if approved, will go to the Council for its final decision on the restriping and use of the Courts in August, 2023.

In May 2023, the Commission approved a Subcommittee recommendation that the Commission's recommendation for the restriping the Courts should be based on the consideration of the following three framework criteria:

1. Safety

This is the physical safety of the Beach Elementary School students.

2. Noise

This is the amount of noise associated with Pickleball play that is experienced by the residents of homes and Beach School near the Courts.

3. Best Use of Space

This is what the Subcommittee judges to be the fullest and most beneficial use of the Courts' space for Piedmont residents.

The Subcommittee recognized that there are other issues associated with Pickleball play at the Courts, but decided that these issues would not significantly influence its final decisions and recommendations regarding the Courts. Therefore, the Subcommittee chose to not include them in its evaluation, but rather would focus its evaluation and recommendations on these three areas that would.

City, Staff, and Subcommittee Actions

The City, Staff, and the Subcommittee have taken the following actions regarding each of the three decision considerations.

Safety

- Obtained a traffic assessment conducted by Kittelson & Associates, a transportation engineering and planning consultant, ("Kittelson") from the City Department of Public Works on the traffic effects of Pickleball play on Linda Avenue. The QR survey for tracking play dates and times are noted in this assessment.
- Contacted Piedmont Police Department ("PPD") Captain Chris Monahan and received a statement from him.
- Received community input from multiple sources how Pickleball play affects safely dropping-off and picking-up students at Beach.

Noise

- Commissioned a sound study by Salter Inc., an acoustic engineering consulting firm.

- Received input from Beach Schoolmates Site Leader Sarah Normart.
- Contacted Beach Elementary School Principal Anne Valva and received a statement from her.
- Received community input from multiple sources on the effects of Pickleball noise.
- Partnered with PRD to implement noise-mitigation strategies to the best of their abilities during the Trial.

Best Use of Space

- Considered feedback provided in the Usage Survey.
- Measured the use of tennis court reservations in various locations (Park, CRTC, Hampton, Beach) by resident decal holders over the course of two years of 2021 and 2022.
- Conducted staff and recreation commissioner site audits of Pickleball play at the Courts and the PMS courts, as well as at the tennis-only Piedmont courts.
- Considered day and time Court usage data from the Kittelson traffic assessment.
- Analyzed QR Code Check-in data

Findings

Findings related to the Subcommittee's three decision considerations are:

1. Safety

The Kittelson traffic assessment found, "A comparison between the variation in traffic volumes on Linda Avenue and the estimated trip generation for the Pickleball courts shows the Courts generate substantially less vehicle volume than the typical variation in the number of vehicles traveling along Linda Avenue." Based on their analysis, Kittelson concluded "the conversion of the two tennis courts to four Pickleball courts at Beach Field on Linda Avenue would generate vehicle traffic that would be indistinguishable from the natural variation in traffic along Linda Avenue. Therefore, no adverse effect on traffic operations is anticipated." The Kittelson assessment is Attachment A, which includes data from the QR Code check-ins.

In an email response PPD Captain Monahan stated, "No issues from our end. Drop off and pick up at every school is congested. We have not observed or received any additional concerns related to the school there."

2. Noise

There have been communications from the community, including local residents, saying that they feel Pickleball play does not create annoying noise. However, a petition, comments, and emails communicate that the noise associated with frequent play is quite disruptive for some people living close to the Courts. Some of these communications suggest that the evening time is most disruptive, as well as the constant play throughout the day.

The Staff has attempted to reduce this noise by providing players with lower noise balls and offering lower noise PRD paddles from the approval paddle list on the Courts for those who do not have them.

Beach Schoolmates Site Leader Sarah Normart, said regarding noise that she hears Pickleball popping all day and finds it distracting. She often keeps her door closed during the daytime. The kids haven't commented on the sound of Pickleball and it is less disruptive when the kids are out playing, but she can hear it all day.

Beach Principal Anne Valva was out until the end of July, but sent a note saying, "We're not bothered by the noise."

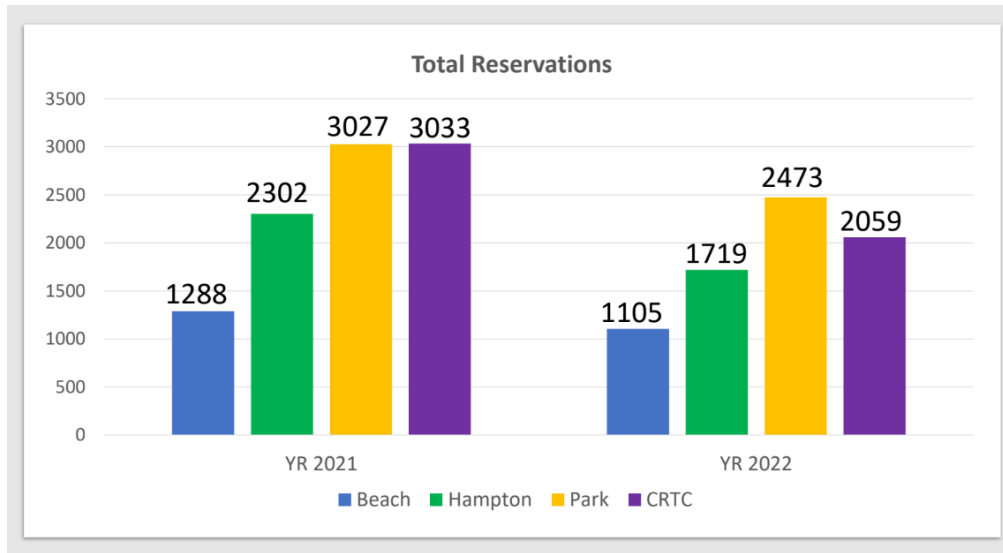
In correspondence with PPD Captain Monahan he stated, "We were receiving some noise calls early in the process. We dispatched staff and did not confirm any dramatic noise concerns beyond the usual. We did speak to the reporting party and explained how we were responding to his complaints. He called me the next day and apologized. He was not trying to trigger a response to his noise concerns, he just thought that was the best way to track his noise complaints. No further calls beyond that."

Staff retained Salter Inc., a San Francisco based acoustical consulting firm that was founded in 1975, to conduct an acoustical survey of Linda Beach Park to investigate noise from the Courts. Their report stated, "Our measurement data indicates that pickleball does not increase noise levels above those considered 'normally acceptable' by the City General Plan. Additionally, because this is a sport activity (that does not involve noise generation from mechanical means) occurring in a recreational zoning, we do not consider this to be a violation of the Municipal Code. (Attachment D). However, we did observe that pickleball noise is audible in the residential zoning adjacent to the courts – such as at homes along Sunnyside Avenue and Howard Avenue. As a 'good neighbor' effort, noise reduction strategies could be implemented to reduce pickleball noise transfer." Salter's Pickleball Noise Survey is Attachment B.

3. Best Use of Space

The Subcommittee considered what is the best use of space to best serve the greatest number of Piedmont residents with recreational opportunities. For tennis use, the Courts are comprised of two sub-standard sized courts. They are not usable for USTA tennis and the overrun areas do not meet the recreational standards of safety. The Court's condition is poor due to cracks caused by tree roots and it must be repaired. It is due to this repair that there is an opportunity to potentially change the striping to allow for only Pickleball, only tennis, or a combination of both.

As the PRD reservation data below shows, Piedmont tennis courts were reserved in 2021 and 2022 by tennis decal holders at Hampton, Park Courts, and the Corey Reich Tennis Center (“CRTC”) significantly more than at Beach.

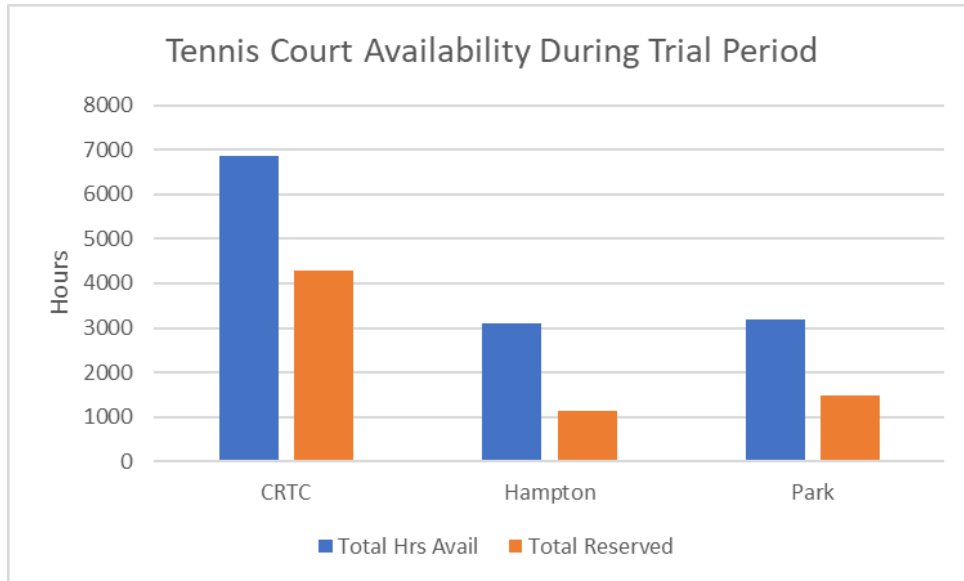


Additionally, while a maximum of eight people could potentially play tennis (with safety hazards due to the lack of overrun space), up to 16 people - double the number of tennis players - can play Pickleball in that configuration. When used as Pickleball courts, this space can potentially serve twice as many players compared with when used as tennis courts.

The Court repairs will not change the size of the footprint of the Courts to meet USTA regulations. Due to the size and shape of the Courts, Pickleball play is rotated at a 90 degree angle and four Pickleball courts fit into the space of the two sub-standard tennis courts.

When plotted on a Piedmont map, tennis reservations made by residents generally show that residents make reservations at each of the four courts throughout the city in a relatively even manner. They do not necessarily go to the closest court to play, as is seen in Attachment E.

The chart below shows the total available hours for each Piedmont tennis court during the Trial, and the number of hours reserved. There has been significant time available at each location for tennis reservations when the Beach courts have been closed to tennis.



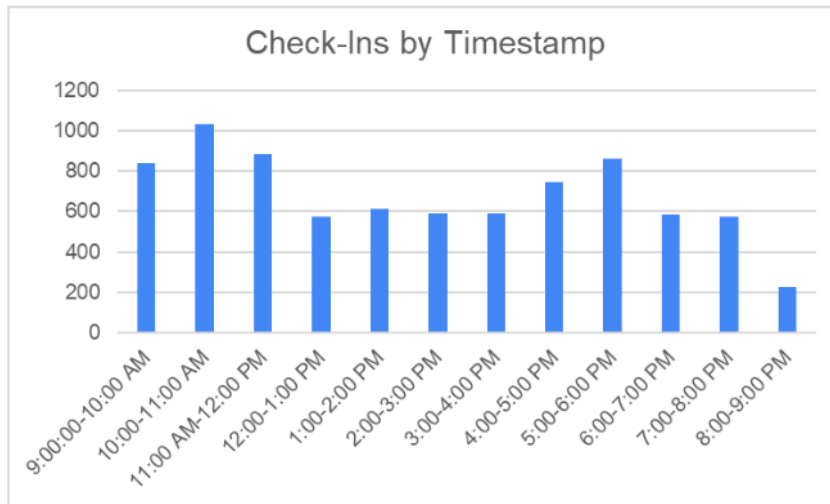
The PMS Sports Courts have also been used for Pickleball play. Throughout the Trial these courts have been available from 9 AM to 5 PM on Saturdays and Sundays, and once the school year ended on Wednesdays from 9 AM to 12 noon. These courts are used through an agreement between PUSD and PRD. They are a shared space. The Pickleball volunteers group has organized and managed the setup and take down of the Pickleball nets. The group has also provided access to the courts at the beginning and end of the day. These additional shared courts are a resource for the Pickleball community, however conditions are subject to change due to potential needs of PUSD.

The QR code posted for tracking Pickleball play at the Courts during the Trial generated a total of 8,168 individual check-ins with related data.

With regards to Court usage, the Kittelson traffic assessment found:

- There is **a consistent distribution of players by day of the week** with Wednesday having the least (11.5%) and Friday and Saturday having the most (15.4% and 15.8%, respectively).
- There is **constant play during the day. Time of day usage usually peaks between about 10 AM and noon and from 4 to 6 PM, and drops off at 6 PM. At 8 PM only 2.2% of play was recorded.** See Attachment A Kittelson Traffic Assessment

The chart below of players' check-in times at the Courts is based on the QR Code check-ins through July 10, and shows a similar time of play distribution.



Beach Schoolmates Site Leader Sarah Normart said, regarding the use of courts, she loves that people are using the courts and would love for the kids to have access. Some volunteers offered to teach a few lessons in the spring; she would like more opportunities for kids to get on the Courts next year.

The Staff and Commission sought out and considered public comment on Pickleball play in Piedmont since 2016 in many different ways. Most recently, the City invited residents to share how the Trial has affected their recreational activity choices by completing an online Beach Courts Pickleball Trial Survey (Attachment C) that was available June 12 through July 2, 2023. This Survey was intended to gather information not being collected through other channels, specifically focusing on how the Trial has impacted individuals' tennis and Pickleball play. Additionally, respondents had an opportunity to provide open-ended feedback on the Trial. There were 810 responses to the Survey and 563 comments, which the Subcommittee read and considered. The feedback is consistent with feedback provided in other communication forums..

Conclusions

There is no evidence Pickleball play at the Courts has created a safety hazard for students, school leaders, or the police department..

The number of people who would enjoy recreation by playing Pickleball on the Courts would be significantly greater than the number of people who would play tennis or engage in some other recreation on the Courts. There continues to be tennis courts available throughout Piedmont, and residents are able to travel across town to play at the various courts.

The opportunity to play Pickleball in Piedmont has created a community that has enriched the lives of many participants, and especially older adults. Given the growing demand for Pickleball and wide range of court options throughout Piedmont, creating a dedicated space for the sport best serves the needs of the community. The benefit of a dedicated space for playing Pickleball ensures better logistics for managing the space and allows for permanent equipment and clear striping to be installed which would enhance the activity.

Restriping the courts for both Pickleball and tennis would not solve the increase in demand for dedicated Pickleball space. The logistics of Pickleball set-up is challenging. The benefit of four dedicated Pickleball courts far outweighs the benefits of mixed-use space. There has been demonstrated demand for an increased number of Pickleball courts in Piedmont and there is the availability of tennis courts in Piedmont as well.

The primary concern with this recommendation is the noise issue. Some residents have said specifically that they do not have any complaints about the noise. However, others have stated that the noise throughout the day and early evening has been disruptive to their lives. As part of being “good neighbors,” this Subcommittee seeks a compromise as a solution for this issue.

Therefore, the primary issue to be addressed in this Subcommittee’s recommendations is how Pickleball can continue to be played in Piedmont while minimizing its negative noise effects on some people who live near the Courts.

Recommendations

The Subcommittee recommends the following:

1. The Courts be restriped for permanent Pickleball only play and they be used as Pickleball courts with permanent Pickleball nets. The courts at CRTC, Piedmont Park, and Hampton Park should remain exclusively tennis courts, and the multi-use courts at the Piedmont Middle School (“PMS”) should continue to be available for Pickleball when school is not in session, or otherwise being used for student-centered programming and as approved by PUSD.
2. The hours of Pickleball play at the Courts be limited to 9 AM to 6 PM each day of the week.
3. At the conclusion of the Trial on July 31, 2023 from August 1, 2023 until Council considers the Commission’s recommendations, the Courts revert back to the pre-Trial dedicated Pickleball hours (i.e., Monday, Tuesday, and Thursday from 10 AM to 1 PM.).
4. To encourage Pickleball play at the PMS courts, Staff should work with the PUSD to maximize the time available for Pickleball play at these courts, especially in the late afternoon and evening.
5. Only low noise balls and paddles be used on the Beach courts. Players will be expected to comply with an approved low noise equipment list posted at the courts. This list should be updated as necessary by PRD. The Subcommittee recognizes that the cost of low noise equipment could be a barrier to court access therefore the Subcommittee requests that PRD develop a check-out system to provide equipment to those who need it.
6. Continue to leverage the Pickleball community leadership group to help communicate the low-noise equipment rules. PRD should conduct regular audits of the Courts to ensure the rules are being followed.
7. The City should request specific noise reduction strategies from the sound consultant, such as sound barriers, that would further reduce Pickleball noise transfer at the Courts.

8. A future Commission tennis and Pickleball subcommittee should be formed to review the possibility of reservations, court fees, and rules.
9. The appropriate City department reviews passenger loading signage near the Courts at Beach Elementary School.

RE: Beach Field Pickleball Courts

The City of Piedmont's recreation department has implemented a trial program at the Beach Tennis Courts to transform the combination tennis/pickleball courts to exclusively pickleball. There has been some concern from the community with this transformation with one of the concerns related to increased traffic volume on Linda Avenue and associated impacts to traffic safety. This technical memorandum documents the findings of an assessment of how the transformation will affect traffic volumes in the vicinity.

Available Data

The city of Piedmont provided data that included both traffic counts on Linda Avenue and information on the use of the pickleball courts during the trial period. Details of the data provided include:

- 24-hour vehicle counts on Linda Avenue:
 - Northbound: 5/22/2023 – 5/25/2023, 5/31/2023, and 6/1/2023.
 - Southbound: 4/28/2023 – 5/14/2023
- Information on pickleball players (3/1/2023 – 6/14/2023) including:
 - Arrival times
 - Number of players
 - Transportation mode of arrival (walk, bike, car, etc.)
 - Estimated time of play

These data were analyzed and summarized to assess how the transformation could affect traffic volumes on Linda Avenue.

Linda Avenue Volume Data

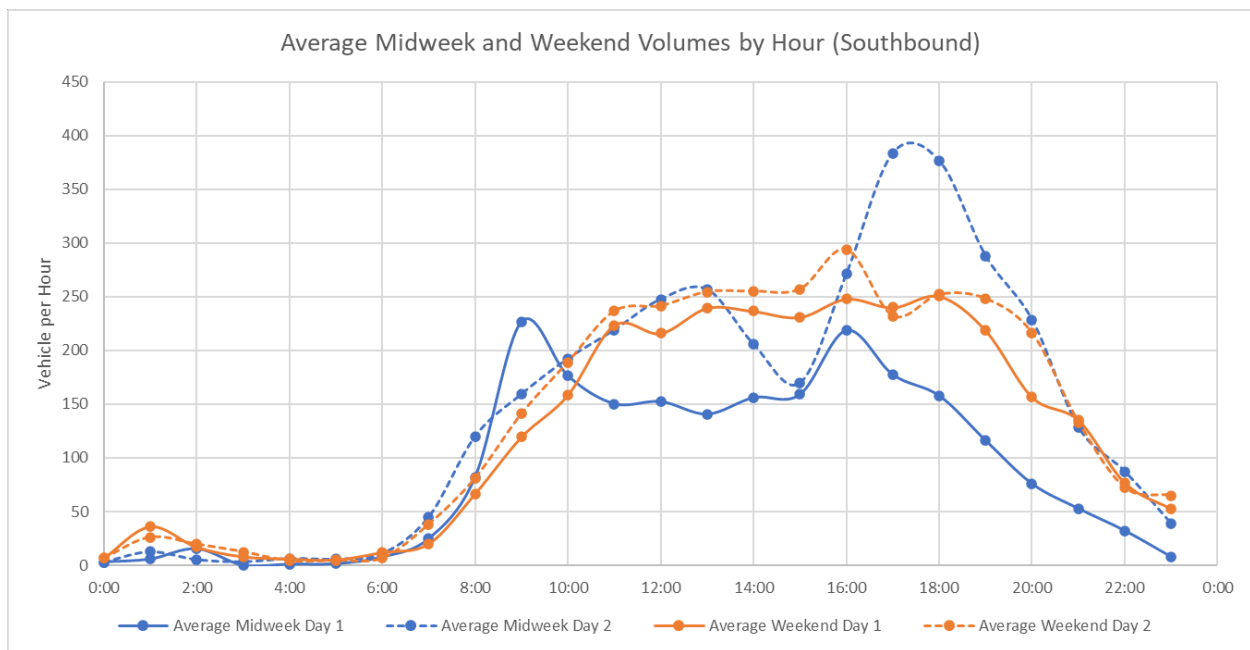
Volume data were collected in both the northbound and southbound directions on Linda Avenue. The dataset provided for southbound Linda Avenue is more robust covering a two week period providing two data days for each day of the week. Therefore, only the southbound data is used for comparison purposes in this memorandum. The fluctuations in northbound vehicles should be similar to what is happening for southbound vehicles.

Detailed comparisons of hourly volumes from one week to another for the same day and hour of the week are provided in Appendix A to illustrate how southbound vehicle volume fluctuates on different days. To

summarize these data, Figure 1 was created which compares the averages for day one and day two of midweek days (Tuesday – Thursday) and weekend days (Saturday & Sunday) for the southbound data collection period. This figure illustrates that volumes by hour can vary significantly from day to day.

Based on these midweek and weekend day averages, the hourly volume variation averages a difference between the two days of about 62 vehicles per hour and up to 219 vehicles per hour on midweek days. Weekend days average an hourly difference of about 15 vehicles per hour and up to a difference of 60 vehicles per hour. This shows that variation in traffic volume is normal, even when comparing similar days of the week at the same time.

Figure 1: Vehicle Variation by Hour for Midweek and Weekend Days



Pickleball Players

Data provided by the City also included detailed information on over 6,000 pickleball players who used the courts between March 1st and June 14th which allowed Kittelson to understand arrival and usage information. Data summarized from this dataset included:

- Duration of play
- Transportation mode choice
- Day of week
- Hour of day
- Patrons per hour

Duration of Play

Table 1 shows the duration of play for the pickleball players using the Beach Field Courts summarized into four time periods. The majority of players usually spend between 1 and 2 hours at the courts with the second most popular time being more than two hours. Only about 17% stay less than an hour indicating the four pickleball courts turn over less frequently than once per hour.

Transportation Mode Choice

Pickleball players were also asked how they arrived at the pickleball courts. Table 2 shows how players responded with about 75% driving to the courts and 25% using an alternative mode such as walking (17%). These findings indicate that the overall vehicle trip generation is about 75% of the number of players arriving at the court.

Day of the Week and Hour of the Day

Time stamps for the pickleball courts show the most popular days of the week (Table 3) and hours of the day (Table 4) for pickleball. Distribution of players by day of the week is relatively consistent across all seven days with Friday and Saturday being a little more popular. Time of day usage usually peaks between about 10 AM and noon and 4 – 6 PM. Since the pickleball courts do not open until 9 AM, they would not conflict with the AM peak hour but the afternoon peak for the courts is during the traditional commute peak period (4 – 6 PM).

Vehicles Per Hour

Based on the information provided by the city and summarized in Table 1 through Table 4, Kittelson was able to estimate the vehicle trip generation of the pickleball courts by time of day (Table 5) for each day of the week. As shown, the number of vehicles arriving to play pickleball averages about four cars per hour with a maximum of seven cars per hour.

Trip Generation Vs. Linda Volume Variation

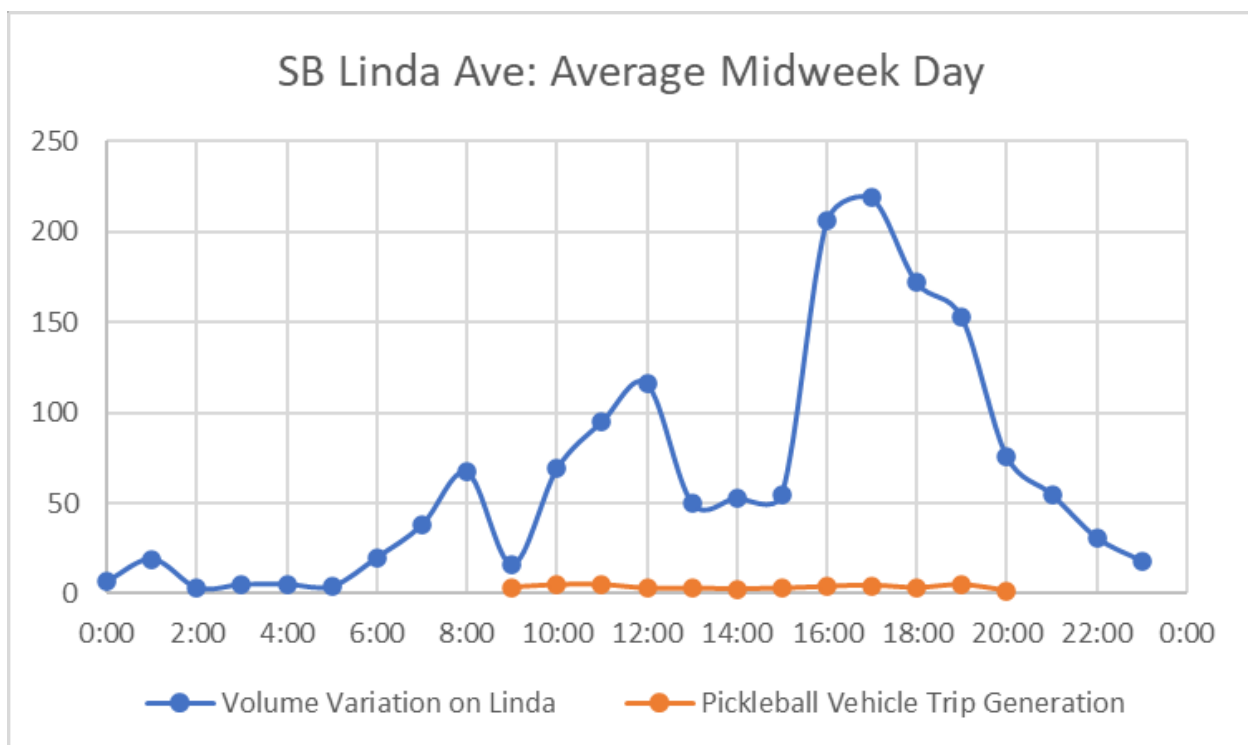
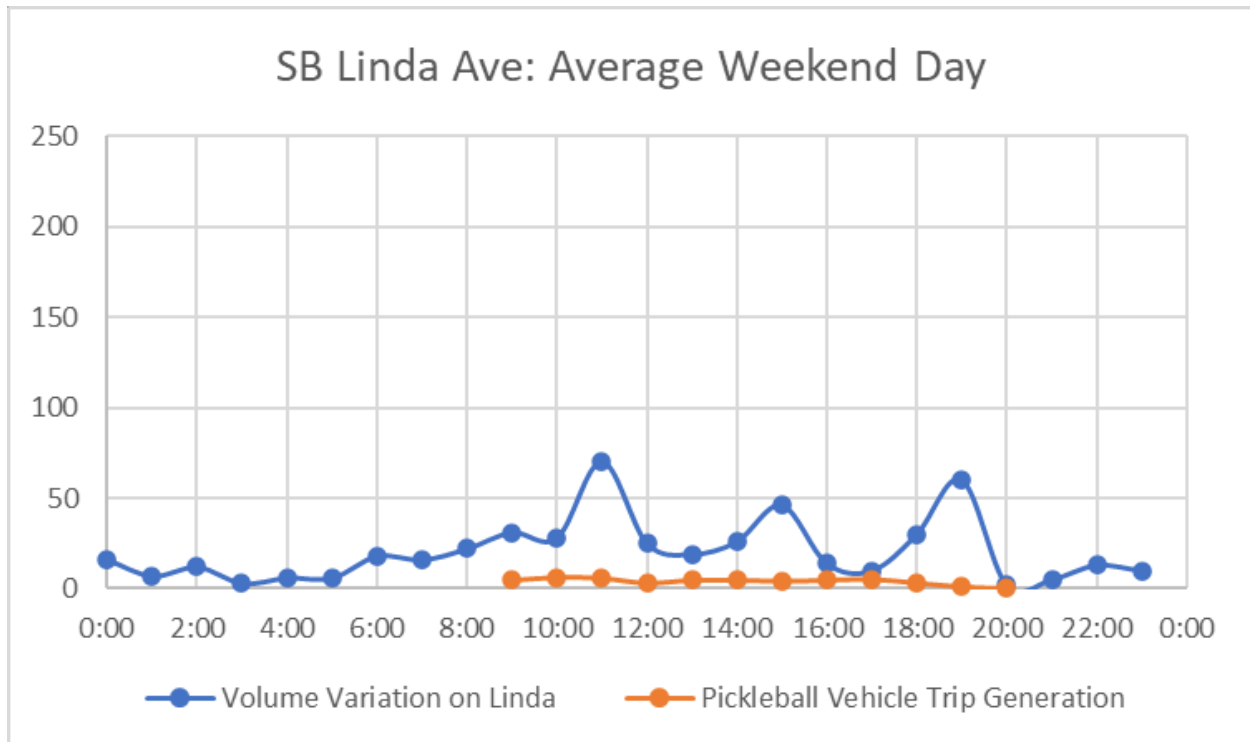


Figure 3: Average Weekend Day Vehicle Variation on Linda Vs. Pickleball Vehicle Trip Generation

Kittelson performed a comparison between the vehicle trip generation for the pickleball courts documented in Table 5 and the variation in vehicle volumes observed on southbound Linda Avenue between the same weekday but on different weeks. Appendix B shows the detailed comparison for each day of the week while Figure 2 and Figure 3 show a simplified version comparing the average of the midweek days and the average of the weekend days, respectively. As shown, the variation in traffic on Linda Avenue from one week to another is significantly higher than the trip generation for the pickleball courts. This indicates that the resulting vehicle trip generation from the pickleball courts is indistinguishable from normal variation in traffic on Linda Avenue.

Figure 2: Average Midweek Day Vehicle Variation on Linda Vs. Pickleball Vehicle Trip Generation

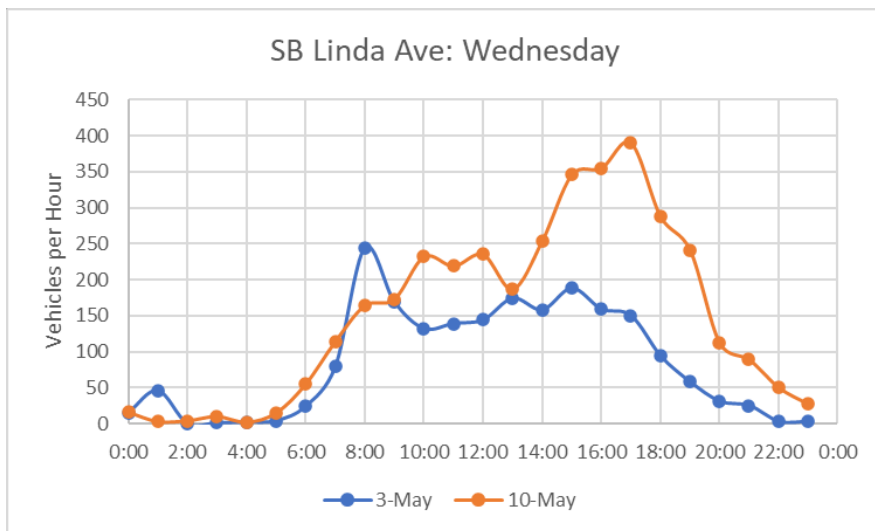
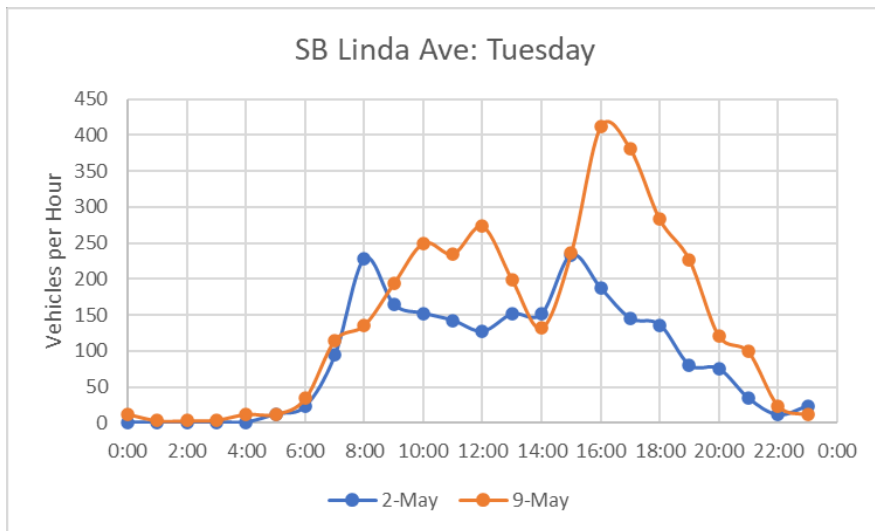
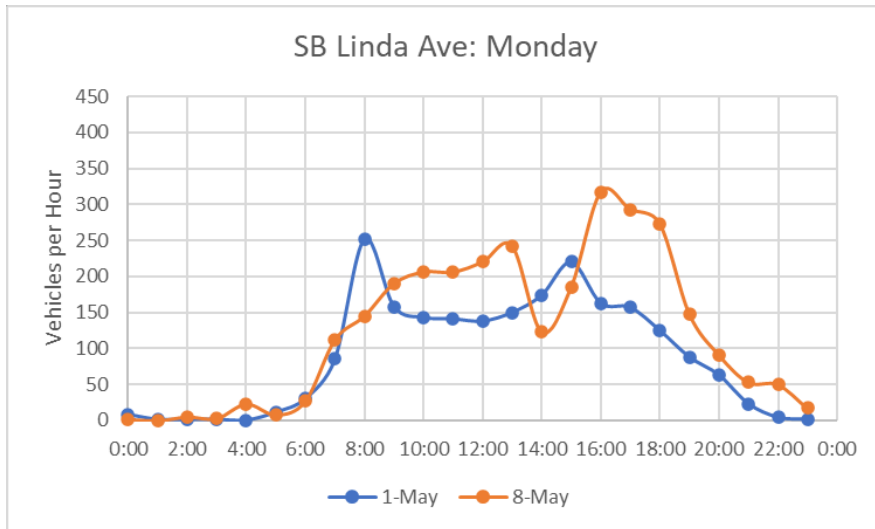

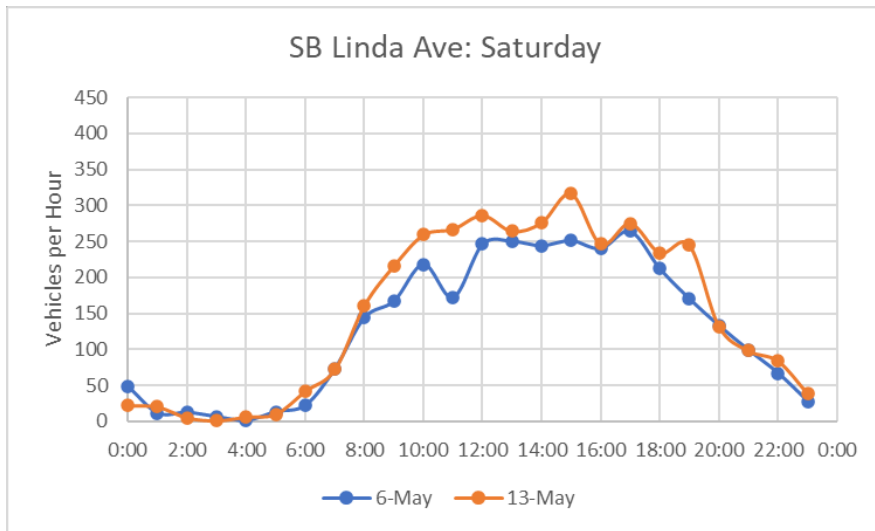
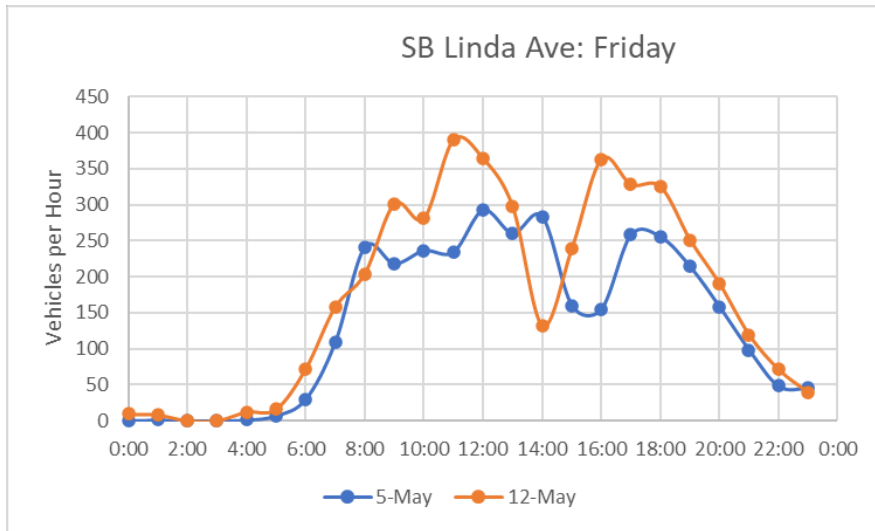
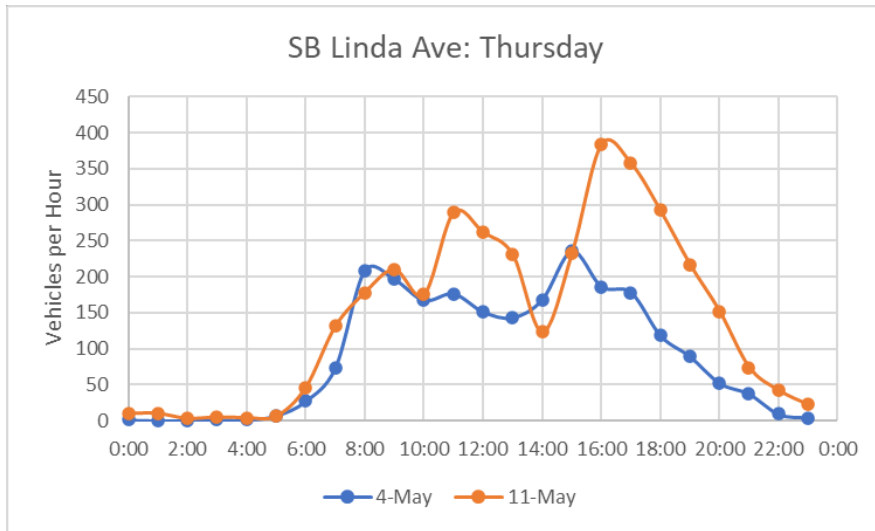
This technical memorandum documented the potential increase in vehicle traffic as a result of the permanent installation of four pickleball courts at Beach Field. Key findings from this analysis include:

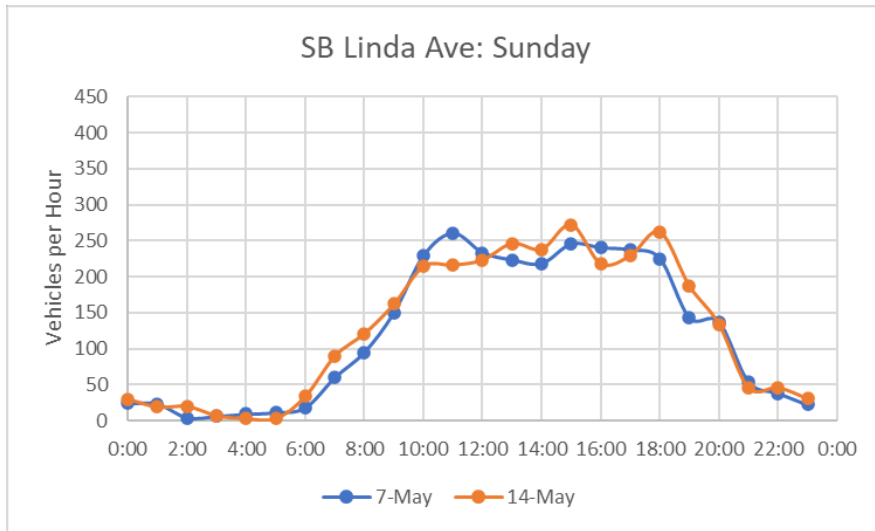
- Traffic on Linda Avenue was found to vary for similar midweek days by an average of 62 vehicles per hour and up to 219 vehicles per hour.
- About 83% of pickleball players play for an hour or more and 25% arrive at the courts via a non-auto mode. Based on the provided data, Kittelson estimates the pickleball courts generate about four cars per hour on average with a maximum of seven cars per hour during their hours of operation (9 AM to 9 PM).
- A comparison between the variation in traffic volumes on Linda Avenue and the estimated trip generation for the pickleball courts show the courts generate substantially less vehicle volume than the typical variation in the number of vehicles traveling along Linda Avenue.

Based on our analysis, Kittelson concludes that the conversion of the two tennis courts to four pickleball courts at Beach Field on Linda Avenue generate vehicle traffic that would be indistinguishable from the natural variation in traffic along Linda Avenue. Therefore, no adverse effect on traffic operations is anticipated.

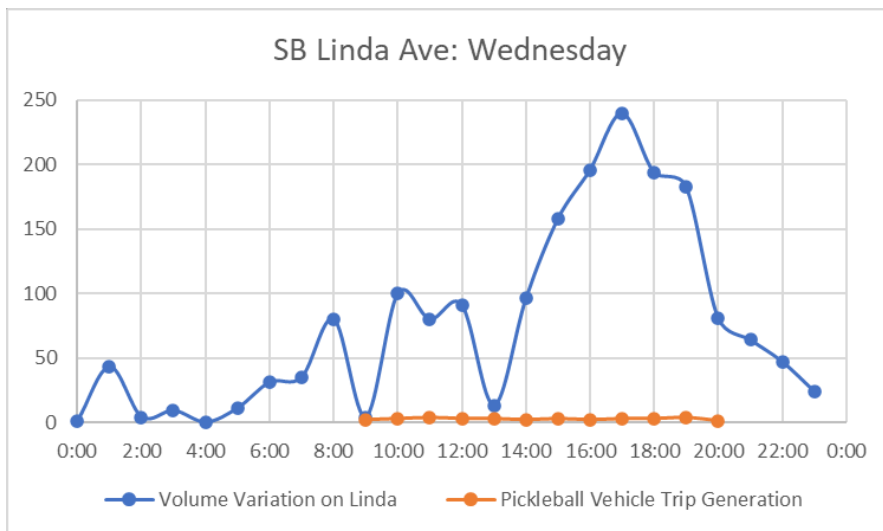
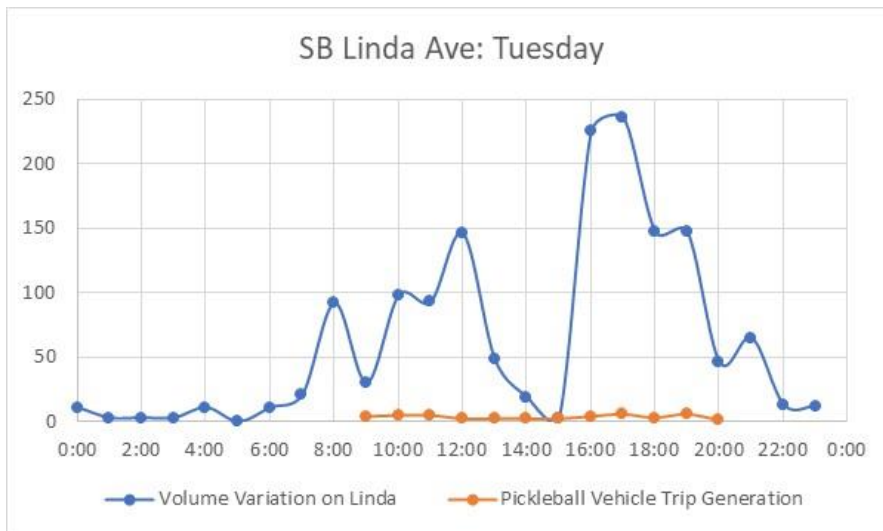
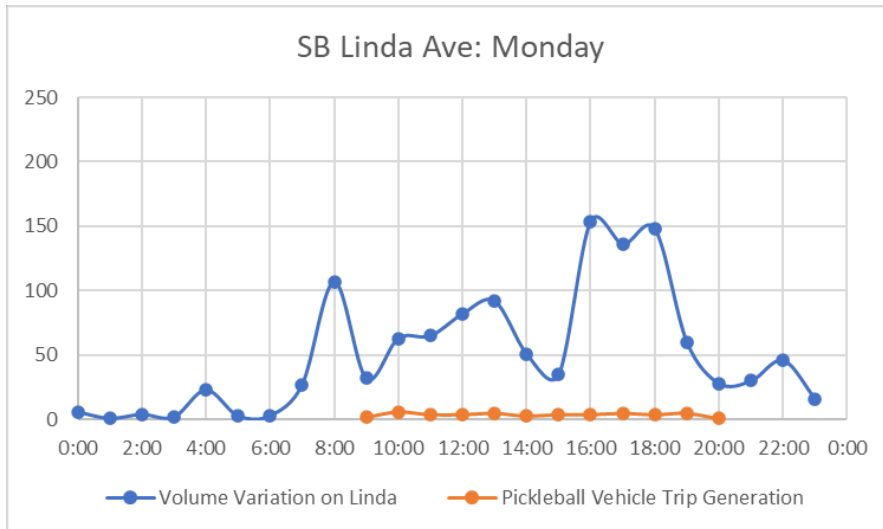

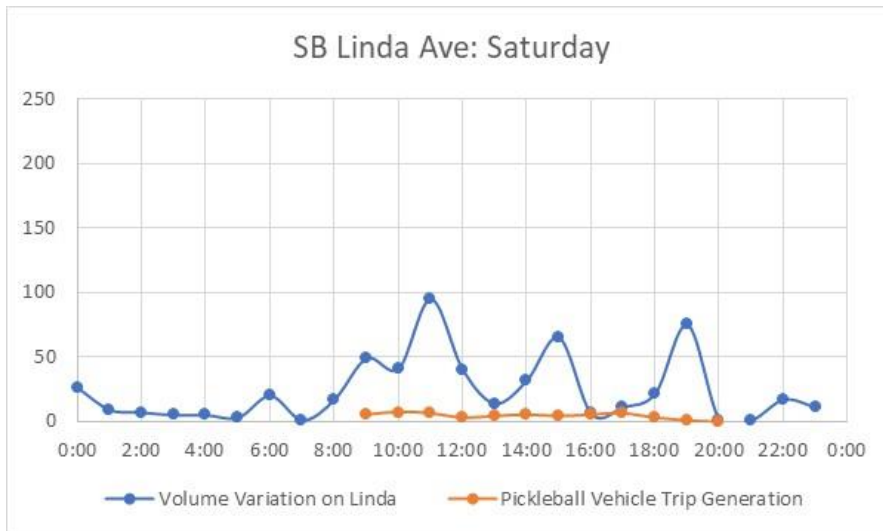
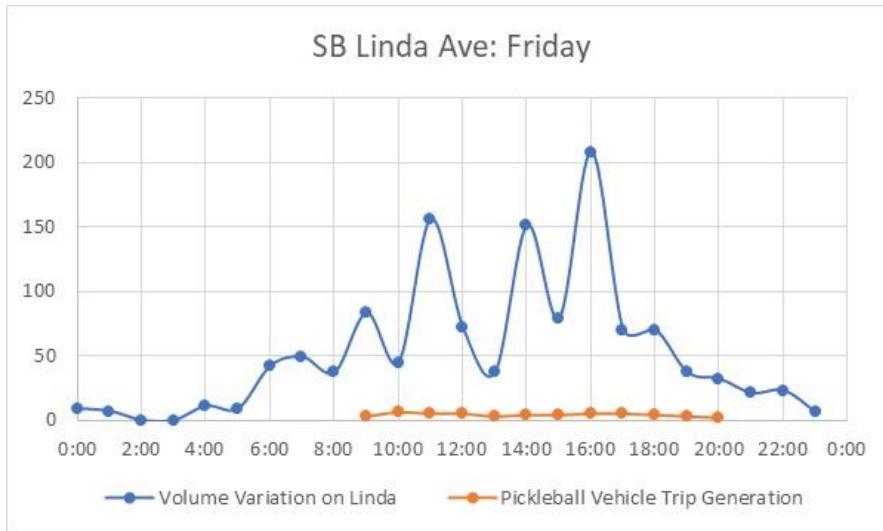
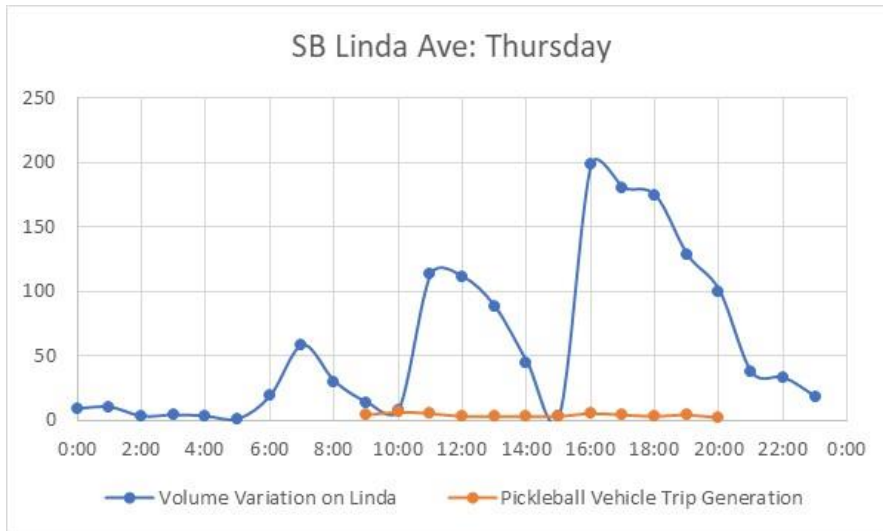


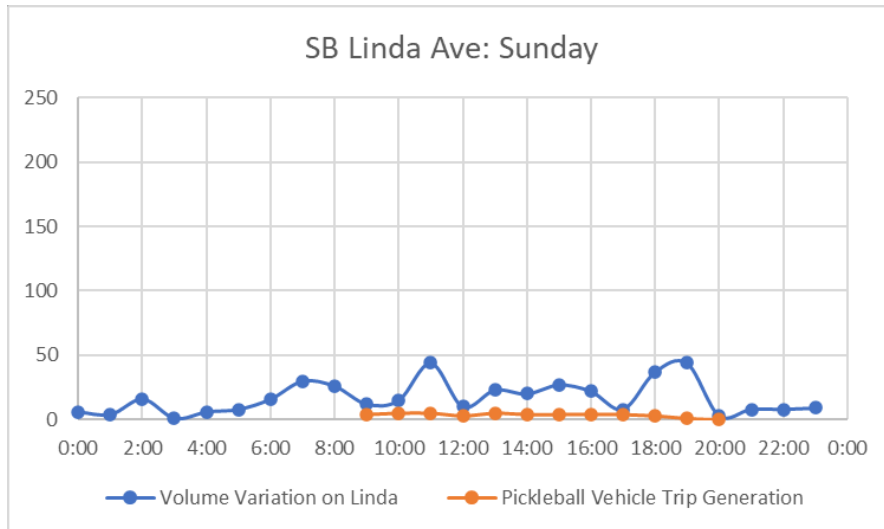




Appendix B: Volume Variation vs. Pickleball

1.0 INTRODUCTION

We have conducted an acoustical survey of Linda Beach Park to investigate noise from the pickleball courts. One of the purposes of our survey was to examine potential impacts generated by increasing court hours of use. We understand the courts are currently in a trial period with hours of use from 9 am to sundown, 7 days per week. Previously, the courts were available for pickleball on Mondays, Tuesdays, and Thursdays from 10 am to 1 pm only. This report summarizes our pickleball measurements and compares noise levels to applicable City standards. The report is separated into the following sections:

1.1 Executive Summary

Our measurement data indicates that pickleball does not increase noise levels above those considered “normally acceptable” by the City General Plan. Additionally, because this is a sport activity (that does not involve noise generation from mechanical means) occurring in a recreational zoning, we do not consider this to be a violation of the Municipal Code.

However, we did observe that pickleball noise is audible in the residential zoning adjacent to the courts – such as at homes along Sunnyside Avenue and Howard Avenue. As a “good neighbor” effort, noise reduction strategies could be implemented to reduce pickleball noise transfer. We are available to provide additional input as needed.

2.0 CITY STANDARDS

2.1 Piedmont General Plan

Table 6-4¹ of the Piedmont General Plan (shown on the following page for reference) provides

Regarding noise level increases, the General Plan notes:

In general, increases in noise of less than 3 dB L_{dn} are not perceptible. A 5 dB increase can trigger a noticeable change [sic] is sometimes used as [sic] threshold to identify a “significant” noise impact under the California Environmental Quality Act.

Action 22.B provides guidelines for acoustical study requirements and includes the following:

Action 22.B: Acoustical Study Requirements: *On an ongoing basis, require acoustical studies for projects which could potentially elevate noise levels above the “normally acceptable” limits specified in Table 6.4*

Action 22.C provides input for playfields and states the following:

Action 22.C: Playfield Hours of Operation: *Define and enforce hours of operation for Piedmont Sports Field, Coaches Playfield, Linda Playfield, Dracena Park, and any other athletic fields that may be developed during future years. Noise levels at city parks should be periodically monitored to ensure that limits on hours of operation are sufficient to maintain neighborhood peace and quiet.*

2.2 Piedmont Municipal Code

The Piedmont City Code³ contains allowable hours for construction noise (Section 12.8.2(a)), restricts the use of gas-powered blowers (Section 12.8.2(b)), and limits noise generated by mechanical equipment,

such as HVAC (Appendix AK, Section AK105). The Code does not include quantitative noise criteria for recreational uses, such as pickleball, but states the following in Section 12.8.

Section 12.8: Noise Declared Nuisance: *Notwithstanding any other provision of this Code, and in addition hereto, it is unlawful for any person to willfully make or continue or cause to be made or continued or to allow any animal to make or continue to make any loud, unnecessary, or unusual noise which disturbs the peace and quiet of any neighborhood or which causes discomfort or annoyance to any reasonable person of normal sensitivity residing in the area. Such noise is declared to be a nuisance.*

12.8.1: Standards to Be Considered: *The standards which shall be considered in determining whether a violation of the provisions of this section exist shall include, but not be limited to, the following:*

- a. *The sound level of the objectionable noise;*
- b. *The sound level of the ambient noise;*
- c. *The proximity of the noise to residential sleeping facilities;*
- d. *The nature and zoning of the area from which the noise emanates;*
- e. *The density of the inhabitation of the area from which the noise emanates;*
- f. *The time day or night the noise occurs;*
- g. *The duration of the noise and it's tonal content;*
- h. *Whether the noise is continuous, recurrent, or intermittent;*
- i. *Whether the noise is produced by a commercial or non-commercial activity;*
- j. *The intensity of the noise;*
- k. *Whether the noise is natural or unnatural;*
- l. *Whether the noise is usual or unusual.*

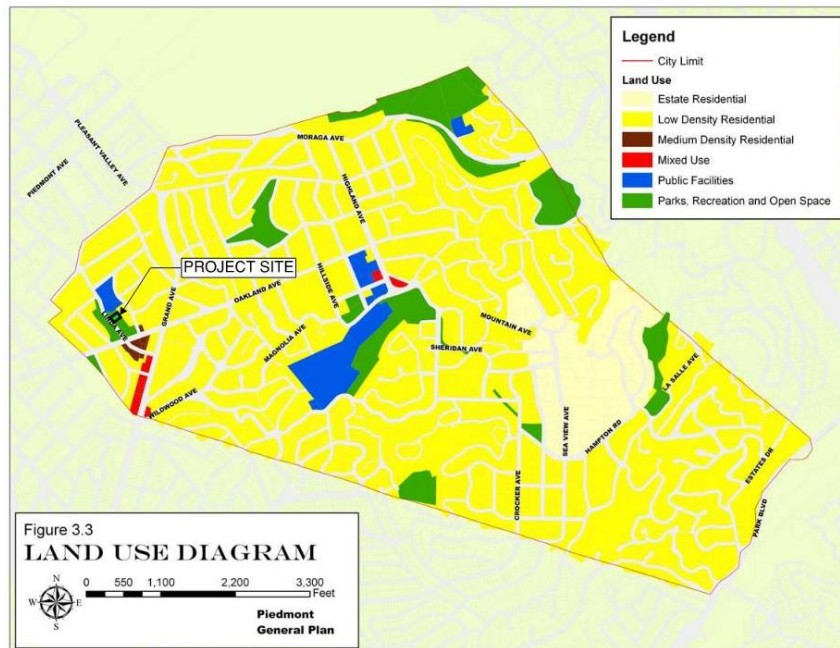
3.0 SITE DESCRIPTION

The pickleball courts are adjacent to Beach Elementary School and Linda Playground to the north, single-family homes to the east, Beach Play Field to the south, and Linda Avenue to the west. There are currently 4 pickleball courts and they are oriented in the north-south direction – perpendicular to the tennis courts. See **Figure 1** for reference.

Figure 3.3 from Chapter 3 of the General Plan⁴ (shown below for reference) indicates the closest homes to the courts, located to the east and west are zoned as Low-Density Residential. Thus, the “normally acceptable” exterior noise goal is an L_{dn} less than 60 dB.

4.0 NOISE MEASUREMENTS

To quantify noise levels at the site, we conducted two long-term continuous noise measurements (LT-1 and LT-2) between 18 and 25 May 2023. Our noise monitors were located in a tree (LT-1) and on a utility pole (LT-2) at a height of approximately 12 feet above grade. We also conducted attended short-term measurements on 18, 23, and 29 May 2023 (ST-1 to ST-8). These measurements were taken at an approximate height of 5 feet above grade. **Figures 2 and 3** on the following pages show the locations of our noise measurements.

4.1 Long-Term Measurements

Table 1 summarizes the noise levels we measured at Locations LT-1 and LT-2 and gives a description of each day's scheduled activities on the pickleball courts and rec field as provided by the parks department. Noise levels highlighted in **green** were within the normally acceptable range for low-density residential zoning. Numbers highlighted in **yellow** were within the conditionally acceptable range.

As indicated in **Table 1**, noise levels were generally in the normally acceptable range. The exception occurred on 19 May when the special event on the Beach Play Field, which featured amplified music, increased noise levels at Location LT-2 to be in the conditionally acceptable range. Noise levels otherwise varied +/- 2 dB when comparing days with pickleball, limited pickleball, and no pickleball. This is because, though pickleball activity is clearly audible at Locations LT-1 and LT-2, other noise sources (e.g., the Local Line 12 bus route on Linda Avenue, dog park noise, school activity, aircraft flyovers) also contribute significantly to the site’s ambient acoustical environment.

4.2 Short-Term Measurements

While our long-term noise monitors were collecting data, we conducted simultaneous short-term measurements at locations ST-1 through ST-6. By calculating the offset in measured noise levels we were able to quantify pickleball noise at the additional locations as follows:

ST-1: Southeast of the Courts

Our measurements and calculations indicate that noise levels would be as follows:

- Pickleball 9:00 to sundown: L_{dn} 60 dB
- Pickleball 10:00 to 1:00: L_{dn} 58 dB
- No Pickleball: L_{dn} 56 dB

This location is in the Parks, Recreation, and Open Space zoning. Calculated noise levels are within the normally acceptable range for this use.

ST-2 and ST-3: Linda Avenue south of Oakland Avenue

At Location ST-2, pickleball noise was audible but not measurable above the ambient conditions. Traffic along Linda Avenue, Oakland Avenue, and Grand Avenue were the dominant noise sources. We expect pickleball noise levels to be similar to those measured at LT-2.

At Location ST-3, pickleball was also not measurable above the ambient conditions, and was observed to be only faintly audible (and very occasionally – such as once every few minutes). Traffic along Grand Avenue was the dominant noise source.

Note that these locations are in medium-density residential zoning. Thus, the normally acceptable range is increased to L_{dn} 65 dB.

ST-4: Southwest of Courts

Our measurements and calculations indicate that pickleball noise will be slightly quieter than at LT-1 by approximately 1 dB.

ST-5: Lake Avenue

Pickleball was observed to be inaudible at this location.

ST-6: Courtside west along Linda Avenue

Our measurements and calculations indicate that noise levels would be as follows:

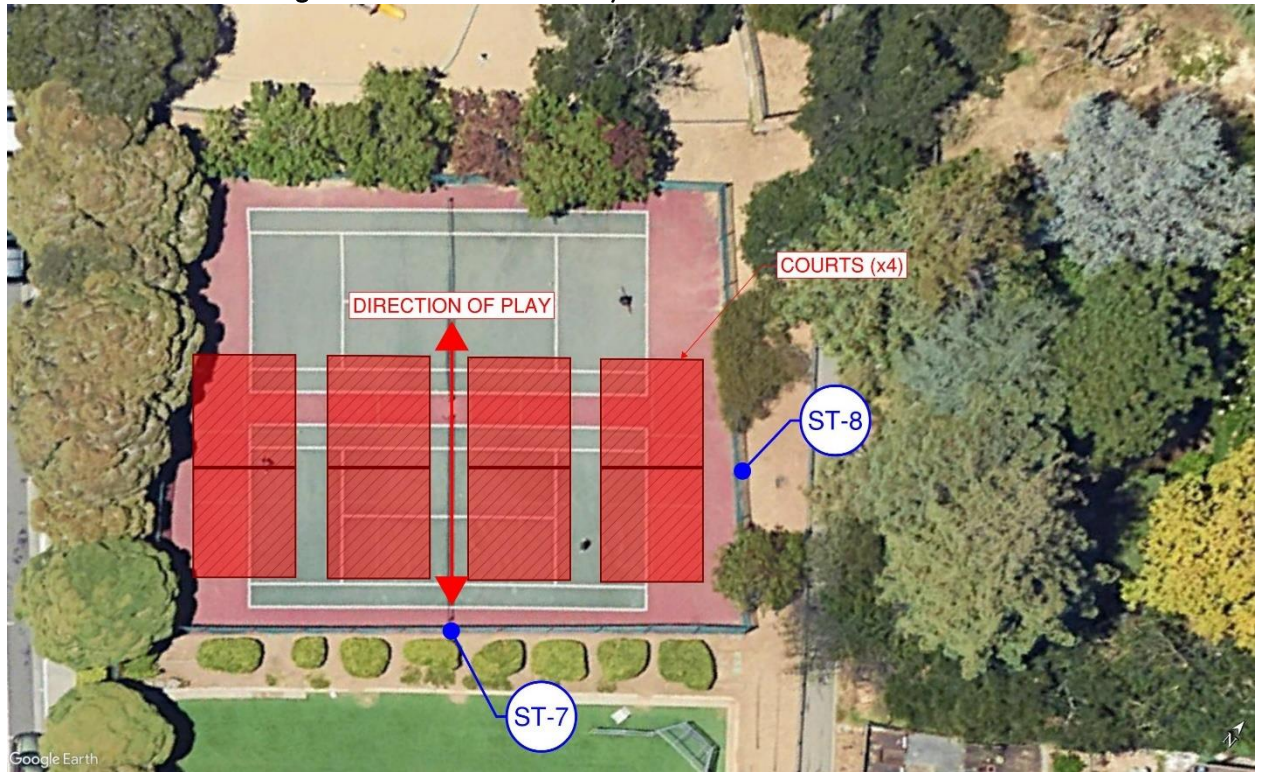
- Pickleball 9:00 to sundown: L_{dn} 59 dB
- Pickleball 10:00 to 1:00: L_{dn} 57 dB
- No Pickleball: L_{dn} 55 dB

This location is also in the Parks, Recreation, and Open Space zoning. Calculated noise levels are within the normally acceptable range for this use.

4.3 Pickleball Noise Directivity

On 29 May 2023, we conducted additional short-term measurements at the eastern and southern boundaries of the court to investigate if noise levels were higher parallel or perpendicular to the direction of play. We measured simultaneously at locations ST-7 and ST-8 from 9:45 to 10:15 am. See **Figure 3** for reference. Noise monitors were mounted on the chain link fence at a height of approximately 5 feet above the court surface. All 4 courts were in use for doubles play (16 players total) during these measurements.

Figure 3: Pickleball Directivity Noise Measurement Locations



Average noise levels measured over the 30-minute interval were as follows:

- ST-7: 69 dBA at approximately 35 feet from the center of the 4 courts
- ST-8: 67 dBA at approximately 55 feet from the center of the 4 courts

Correcting for distance yields the following pickleball noise levels:

- Axis perpendicular to the direction of play (ST-7 side): 65 dBA at 50 feet from the center of the 4 courts
- Axis parallel to the direction of play (ST-8 side): 68 dBA at 50 feet from the center of the 4 courts

This implies some directivity to the noise transfer. This might be due to “shielding” caused by the player’s bodies blocking noise from the balls impacting the paddles and play surface.

4.4 Pickleball Noise Tonality

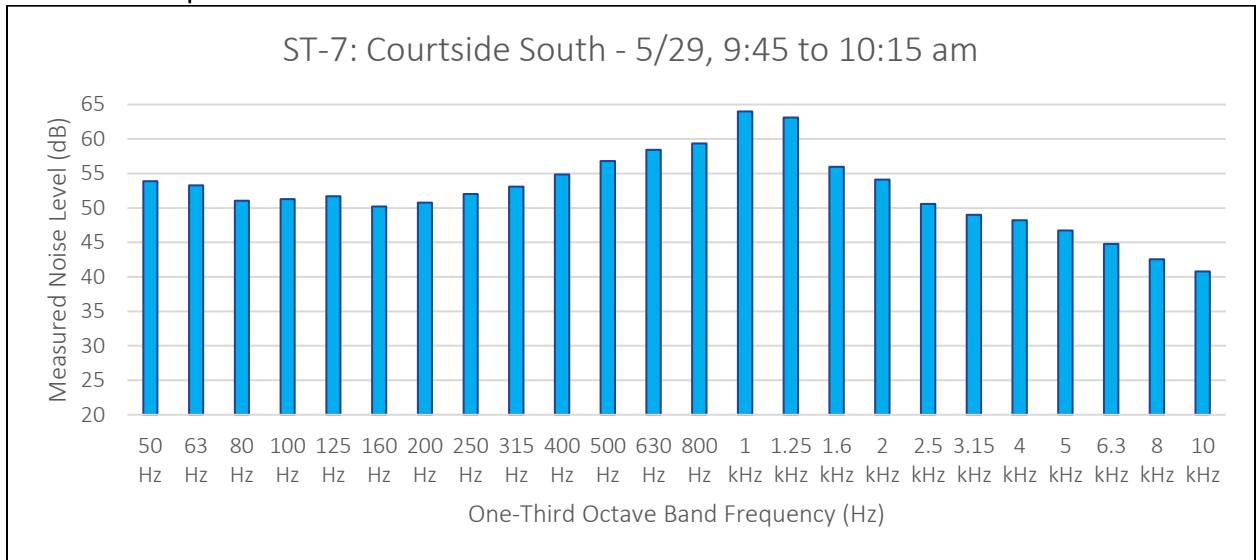
Tonal noise has been defined by the California Department of Health as follows⁵:

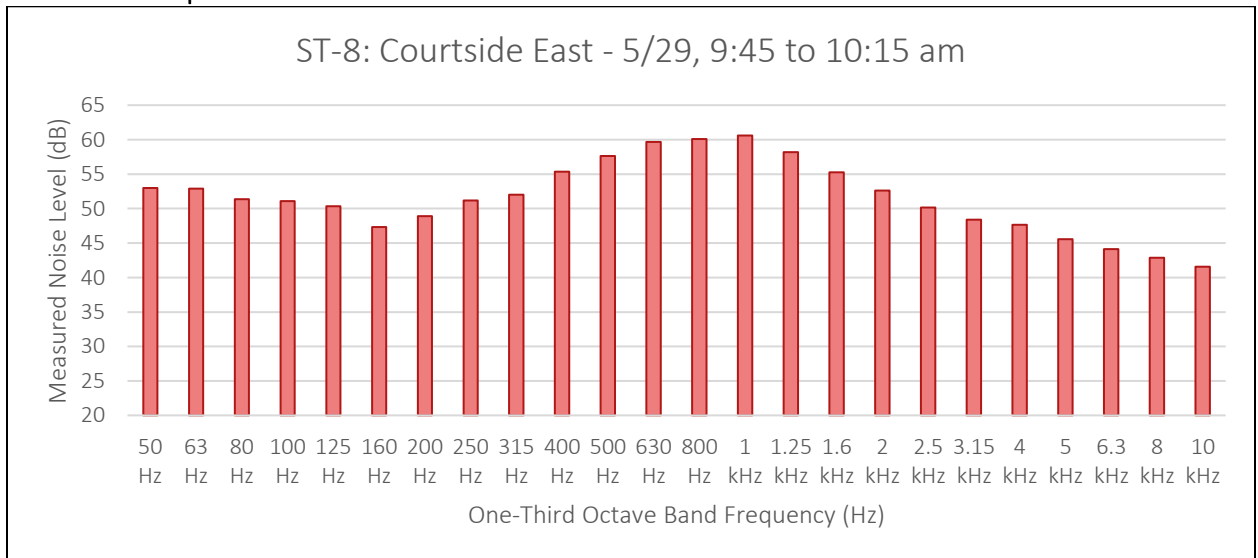
A pure tone shall exist if the one-third octave band sound pressure level in the bandwidth tone exceeds the arithmetic average of the sound pressure levels of the two contiguous one-third octave bands by 5 dB for center frequencies of 500 Hz and above and by 8 dB for center frequencies between 160 and 400 Hz and by 15 dB for center frequencies less than or equal to 125 Hz.

Graphs 1 and 2 show the one-third octave band noise levels measured at locations ST-7 and ST-8 over the 30-minute time interval for pickleball with 16 players total (4 per court with all 4 courts in use).

Graph 1: Measured Pickleball One-Third Octave Band Noise Levels at Location ST-7



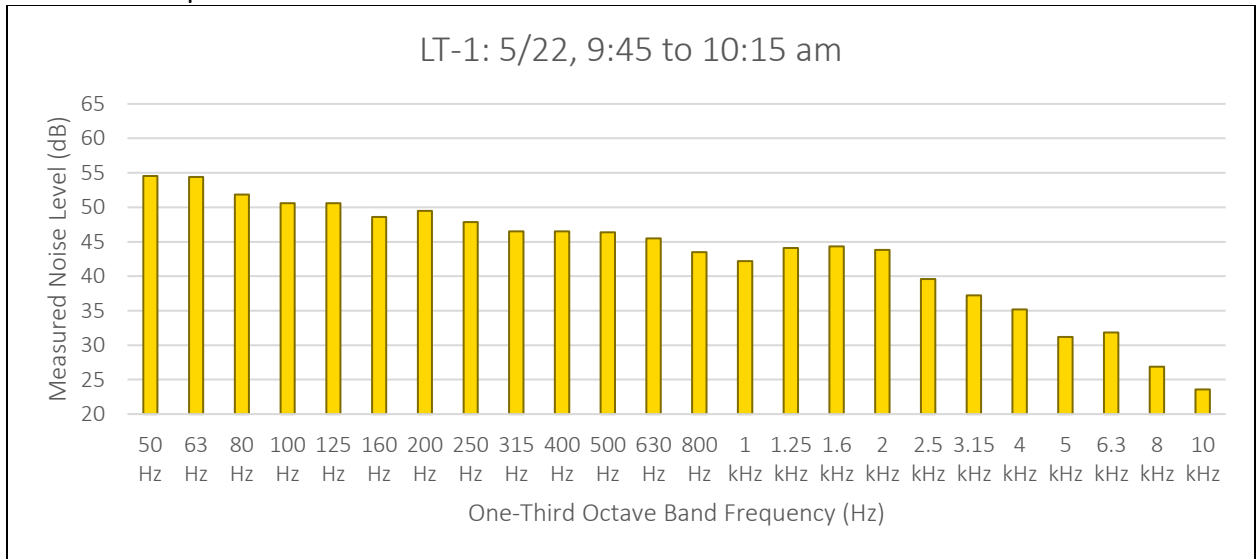
Graph 2: Measured Pickleball One-Third Octave Band Noise Levels at Location ST-8



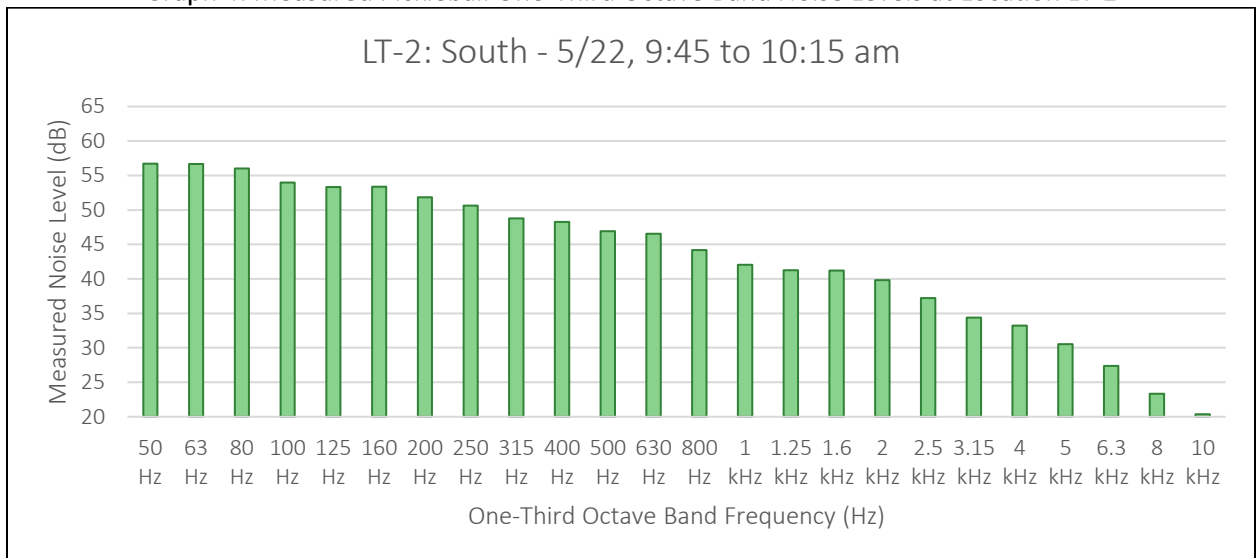
Noise levels were highest in the 1 kHz octave band. However, none of the one-third octave bands exceeded the two contiguous bands by the amounts defined by the Model Community Noise Ordinance. Therefore, pickleball noise is not tonal per this guide.

For reference, Graphs 3 and 4 show measured pickleball noise levels at long-term measurement locations LT-1 and LT-2 the week prior.

Graphs 3 and 4 indicate that higher frequency (e.g., 1 KHz) noise associated with pickleball activity dissipates more rapidly with distance. Thus, noise does not seem to become tonal farther from the courts.



5.0 DISCUSSION OF MUNICIPAL CODE CONSIDERATIONS

Though measured noise levels did not exceed those considered normally acceptable by the City General Plan, there are other standards outlined in Municipal Code Section 12.8.1 that are to be considered. This section provides discussion for these standards.

a. The sound level of the objectionable noise;

As noted in the Noise Measurements section of this report (Section 4.0), measured pickleball noise levels are within the range considered normally acceptable for the associated zoning as defined by the General Plan.

b. The sound level of the ambient noise;

Noise levels varied +/- 2 dB when comparing days with pickleball, limited pickleball, and ambient (no pickleball). As noted in the General Plan, changes of less than 3 dB are generally considered not perceptible and a “less than significant” impact under CEQA.

c. The proximity of the noise to residential sleeping facilities;

The pickleball courts do not have outdoor lighting and are not open after sundown. Therefore, pickleball noise is not expected to cause nighttime sleep interference.

d. The nature and zoning of the area from which the noise emanates;

Pickleball is a recreational use occurring in a Parks, Recreation, and Open Space Zoning.

e. The density of the inhabitation of the area from which the noise emanates;

We assume that court occupancy is limited by applicable fire codes. There are 4 courts with up to 16 players at a time. Based on our observations, there are typically some non-players in the court area as well (i.e., watching or waiting for court availability) – perhaps up to around 25 to 30 people total.

f. The time day or night the noise occurs;

Pickleball noise occurs during daytime hours only; either from 9 am to sundown (extended hours) or from 10 am to 1 pm (pre-trial hours).

g. The duration of the noise and its tonal content;

Pickleball noise seems to occur throughout the hours of court availability. As shown in Graphs 1 to 4, pickleball noise does not appear to be tonal.

h. Whether the noise is continuous, recurrent, or intermittent;

Pickleball noise is recurrent (i.e., it occurs often and repeatedly) during the hours of court use.

i. Whether the noise is produced by a commercial or non-commercial activity;

The noise is produced by a non-commercial activity.

j. The intensity of the noise;

For noise, intensity is typically associated with directivity and overall noise levels. Pickleball noise does appear to have some directivity. However overall noise levels do not exceed those considered normally acceptable for the associated zoning as defined by the General Plan.

k. Whether the noise is natural or unnatural;

Pickleball noise is primarily unnatural – caused by the ball striking the paddles and the playing surface. There is also some natural noise generated by players speaking/cheering.

l. Whether the noise is usual or unusual.

Pickleball noise is usual for a recreational sport court. We understand that use of these courts has included pickleball since April 2019⁶.

6.0 CONCLUSION

We do not find pickleball noise to exceed standards set forth by the City General Plan or Municipal Code.

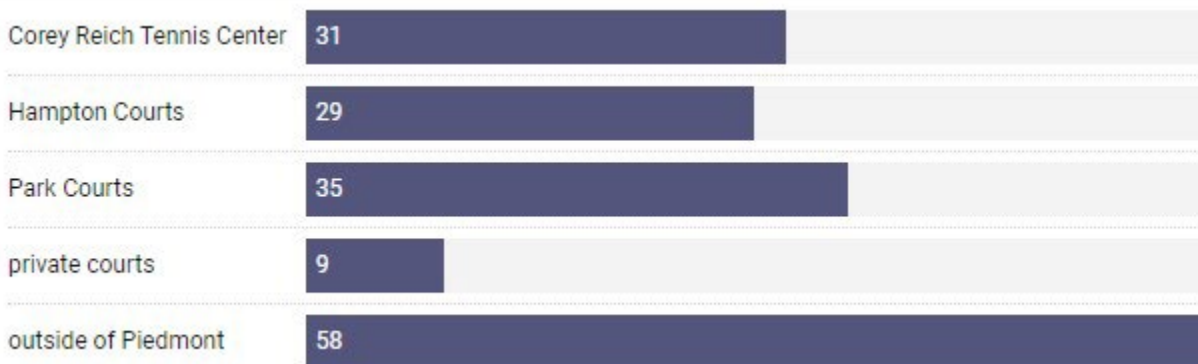


Where do you most often play tennis since the trial began?

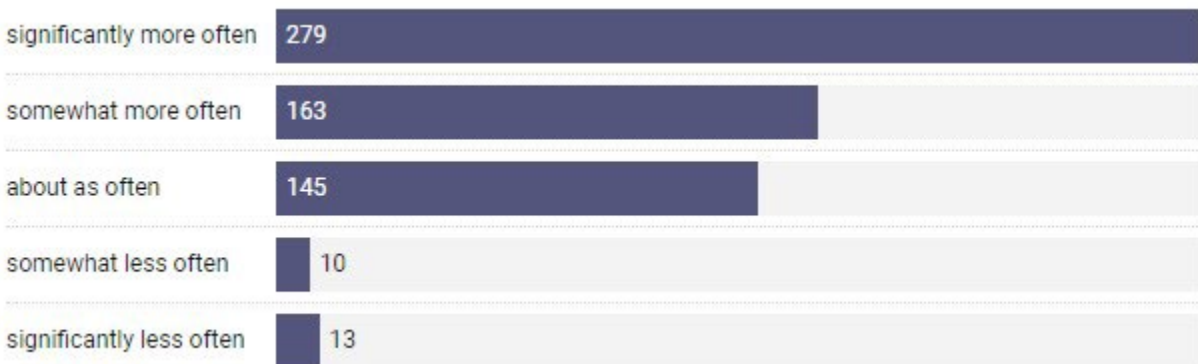


How often do you play pickleball now compared to before the trial began?

1. I have lived on Howard Avenue for 20+ years. I never heard tennis games but can hear pickleball from my front yard. I can only imagine what it is like for residents who live closer to the courts and strongly encourage the Recreation Commission to directly solicit their input and to consider their comments and concerns very seriously.
2. Relatedly, I think the City and the Recreation Commission should have provided more notice to the surrounding neighborhood about the opportunity to provide input. I have often received mailings from the City about various projects and actions that might impact residents, but have received virtually nothing from the City about pickleball. I was surprised to receive an email from the Recreation Department about this survey only a few days before the July 2 deadline to submit it and I'm not sure why the City has not directly notified the surrounding neighborhood about the opportunity for input.
3. As I'm sure the Recreation Commission is aware, pickleball involves more players than tennis — at the Beach courts, tennis involves no more than eight players (two courts with at most four players each), whereas pickleball can involve as many as 16 players (four courts with four players each). The primary impact of pickleball is the sound of the balls when they are hit with the paddles — so, the Recreation Commission needs to consider the fact that pickleball involves twice as many balls and twice as many players compared to tennis.
3. I encourage the Recreation Commission to read a front page article in today's (July 2, 2023) NY Times about the noise impacts of pickleball on neighbors: "the most grating and disruptive sound in the entire athletic ecosystem right now may be the staccato pop-pop-pop emanating from America's rapidly multiplying pickleball courts."
4. This neighborhood is already heavily impacted by daily activity on the Linda Beach playfield — both organized soccer and softball games with cheering (screaming?) parents and adult soccer games with competitive shouting between players. During soccer and softball season, the kids' games can start at 9 a.m. on weekends, and kids' weekday practices continue until 9 p.m.
5. Piedmont has other options for pickleball: there are courts near Piedmont Middle School and also in Piedmont Park and Hampton Park.
6. The City has stated that the Beach courts are "non-regulation" for tennis competition to justify the use of Beach courts for pickleball — I'm not sure why this point carries any weight since the Beach courts are acceptable for recreational tennis. Also, I have not heard the City



state clearly the Beach courts the only non-regulation courts — are the courts in Piedmont Park and Hampton Park regulation? If not, they should also be available for pickleball to alleviate impacts on the Linda Beach neighborhood.

7. I am opposed to any pickleball at the Beach courts for the following reasons: 9i) the noise impacts are significant; (ii) it's not clear that the City has adequately sought and considered input from the surrounding residents; (iii) the Linda Beach neighborhood is already significantly impacted by daily use of the Linda Beach field for soccer and softball; and (iv) it's not clear that the City has considered alternatives to the Beach courts as the sole option for pickleball in a community with multiple tennis courts and significant resources to develop those locations for pickleball to alleviate impacts on the Linda Beach neighborhood.

1. During the summer months, a substantial portion of playing time on ALL Rec, Park and Hampton courts is Not Available to residents due to the summer camps that are in session. For example, during week of July 10 and in following weeks, both Park courts are unavailable from 845 to 1230; all 4 REC courts are generally unavailable from 2pm to 5pm; and the Hampton courts are unavailable from 830 to 11am or 1 pm. Those camps are important to the community. But when the Beach courts were available for tennis, residents could use the Beach courts during summer camp sessions. They can't now. Much harder to find convenient tennis court time now.

2. Pickle ball players sometimes use the Hampton Park backboard to practice. This is very disruptive to anyone playing tennis and should clearly be prohibited

3. The pickle ball noise at the Beach courts is very irritating to those of us who walk by, with dogs or friends.

4. If you decide to extend the pickleball play on Beach courts beyond the trial period, please find some way to erect pickle ball nets which can easily be removed during summer camp season or in other situations.

A dedicated court will go a long way towards fulfilling the needs of Piedmont community

A lot of people seem to be using the courts and having a lot of fun. It's a good thing!

After 20 years of living in the neighborhood and using the courts, at this point, sadly I don't use the Beach Courts at all. Even if there is one the of courts seemingly available (the one in poor condition--uneven surface due to roots), the feeling of the place has completely changed. Pickleball players take over both courts even if they're using only one by stepping into the other one. There is absolutely no way one can use the other court at the same time. Also the noise the players and not to mention the ball makes is too loud and uncomfortable. I can't imagine living near as it echos all over the neighborhood. Simply walking by, I just want to rush and get this part over with when there is pickleball going on. It has become a very unpleasant experience. I believe shared use is simply not doable--not enough space for both. I'd like to see it return to tennis only as a player.

Allowing pickleball only courts at Beach courts would be the best use of the space for the community and pickleball players. Wonderful community of players!

Appreciate and enjoy the welcoming and helpful attitude of fellow players towards newcomers and regulars



As a long term resident of Sunnyside ave. I am very affected by the noise of Pickle ball. It is being played 12-13 hours a day 7 days a week. Not only the actual game being played but all that goes along with it. The yelling, shouting and cheering. This includes the parking issues on Linda which affect the school and the lower playground. I'm all for having fun and playing a sport you love but when it impacts the entire neighborhood it needs to be reimaged. Being a 40yr plus resident of Baja Piedmont, we always seem to absorb the projects and activities that no one else in the community wants in their backyard. There is to my knowledge at least 3 other locations where Pickle ball could be played within Piedmont. I suggest you spread the games throughout the community and share the responsibility. There are 5 courts at Davies make 2 of them designated Pickle ball courts. It's my understanding that the Middle School courts can't be utilized because of school being in session. So I ask you if you can't play during school there, why can you at Beach? It feels like this project needs to be expanded and reworked for everyone's benefit.

As a novice pickleball players, the pickleball community at Beach is very open to all levels of players and a great way to meet people.

As a Piedmont resident, I really appreciate being able to play pickleball at Beach. I enjoy both the camaraderie and exercise!
I can't understand the complaints about noise. I played yesterday and the noise from the many summer camps on the playfield drowned out any pickleball sounds.
If you live near a school or public park you will hear the sounds of people enjoying the facilities.

As a tax-paying resident of Piedmont, I object to the inequitable treatment between pickleball and tennis. I have no interest in one sport being favored over another, even though I am a tennis player. But I don't want my tax dollars to subsidize courts that are open to use without a reservation from people outside the community, and I don't agree with a system where tennis players must have decals to make reservations, and pickle-ball players get free use of the courts at any time. As far as I am concerned, the Rec Commission should make every court usable by both sports, and make everyone pay to reserve a time slot. That would be fair.

As a tennis and pickleball player, I did not like playing tennis on the Linda Beach courts since they are not regulation size. The other Piedmont courts are regulation and seem to be available when I wanted to play

As a tennis player also, I never choose Beach as a playing venue because of it's inadequate spacing. It also makes sense to convert Beach to only pickleball and leaving all the other tennis courts in Piedmont striped ONLY for tennis. Additional lines make it confusing for players of both sports.



As an avid tennis player, I'm a fan of pickleball. It's much easier to learn and play than tennis and I suspect some pickleball fans will graduate to tennis sort of like how people graduate from uke to guitar.

As both a tennis and pickleball player, I can find tennis courts dedicated to tennis but never been able to find courts dedicated to pickleball until Linda Beach, except in Montclair, but very difficult to reserve as so in demand. Open drop-in play is one of the most beautiful things about pickleball- for those who work and/or go to school (like me), drop-in PB is essential. Also that practical reason led to meeting an incredible community of people. The other thing I see of others and now for myself, as we get older, the body is breaking down, and it becomes harder to play tennis but pickleball is possible. I can't tell you how important that is for someone like myself who's been a lifelong athlete, and has been terrified of losing athleticism. Let's face it, our population is aging and pickleball will continue to grow by leaps and bounds, and that's a wonderful thing! Thanks for the trial of Linda Beach. I'm in favor of it becoming permanent.

As someone who lives near the courts (Sunnyside Ave), there is rarely a time of day when I don't hear the sound of the ball being struck over and over and over again, even with my windows closed. I can only imagine what the poor residents of the homes right behind Beach are going through. This activity should be played indoors, or at the very least, a *long* distance from private residences.

At the June Commission meeting, which I was unable to attend, apparently a number of homeowners spoke about the PB noise reaching their homes. Although there are also people around the courts who do not hear or do not care about the noise, I think we need to address the complaints of those residents who are impacted. For that reason I believe you (the Commissioners) and we (the players) need to put our heads together with the sound engineers to select a mitigation method that will reduce the sound to an acceptable level. We will never have dedicated courts if we don't make this Trial work. There is simply no place else courts can be built in our City. Hundred of units of playing time demonstrate how frequently/densely the courts are being used. I am a senior senior and I can't tell you how much being able to play when you feel like it helps me mentally, emotionally and physically. I don't know how many playing years I have left but playing at Beach during this Trial has been wonderful. Let us work together to make this Trial a success. Thanks.

Beach Courts aren't safe for tennis. Perfect for pickleball!



Beach courts for pickleball only make good sense in view of the high demand for this fast growing sport. Seniors in Piedmont do not receive the athletic support accorded other age groups, and a permanent pickleball home at Beach would go a long way toward addressing that need. Sound issues should be addressed with quieter balls and paddles (already in use) and perhaps reasonable limits on time of day playing.

Beach courts should be striped for tennis only at this time until PRD is able to determine the best site for pickleball.

A pickleball trial should be held at Hampton with equal publication and encouragement to determine if site changes use. Once this trial is complete, PRD can appropriately determine how to expand pickleball. This should not happen until the Beach courts are striped to prevent further negative impact on tennis access.

Inquires with expanding hours at PMS should be taken.

What is the status of the Davie Tennis Stadium. As PRD and PUSD has expanding sports needs, and very limited sports space and Oakland clearly is not going to reopen Davie's, is this space that the City should look at repurchasing for a long term solution with creation of a multisport facility (volleyball, pickleball, other turf courts).

What are the finances behind pickleball within Piedmont - how much money was gifted to PMS for court surfacing and striping? How much money has been spent on nets, striping at Hampton (would these stripes now be removed and how much additional would that cost).

What would be the cost of nets on wheels so pickleball players did not need to setup take down, but could just push the nets to the side or back of the tennis court?

What is the distance for houses from court at Hampton? What noise abatements would need to be taken at either site? Is complete elimination of the noise nuisance possible at Beach? at Hampton? How much does noise abatement cost.

How much is court maintenance for tennis only, pickleball only and dual use courts? What is the financial plan for maintenance of courts?

Is PRD willing to put in parameters to completely shut down courts for 1 week or 1 month if non-noise dampening paddles are used (see Berkeley Rose Court rules). How would this be enforced? What if it is consistently shut down due to this; at what point would other uses of space be readdressed?

How does PRD plan to monetize pickleball?

Will PRD change pickleball to reservation system at least during high traffic times to avoid traffic congestion (regardless of site)?

How does PRD plan to support tennis? Will tennis decal remain Piedmont resident only?

How will PRD handle other trials for other sports in the future? This has resulted in significant division of neighborhood and negative view of PRD's ability, willingness and desires to listen to residents, especially in Baja. This survey is created only 8 days prior to you making a decision. Is that really the appropriate and adequate amount of time? What operational parameters can be put in place to avoid this in the future?

Beach would be the first dedicated PB in Piedmont and would enhance the quality of PB play!



Being able to come to the Linda Beach courts far more frequently than before the trial has improved my fitness and mental health. The pickleball community that has developed at the Linda Beach courts is the most welcoming and supportive of any of the many bay areas I have played at. It seems that noise is a limiting factor in the acceptance of pickleball but ball and paddle manufacturers realize this issue and are continuing to design quieter paddles and balls.

I think you will miss a great opportunity to provide a wonderful recreational activity for Piedmont players of all ages if you fail to recommend permanent pickleball lines at Linda Beach. Thank you for the time, consideration and effort you have put into this issue.

Besides Walking on Wednesdays, pickleball is the one of the best active activity for seniors in Piedmont. This has been a great opportunity for more seniors to get together to meet one another in our own community.

Courts at PMS are crowded and it's a a long walk up a big hill!

Davie Tennis Stadium, which is located in Piedmont, has been shut completely for months because Oakland has been unable to direct resources to the property to remove a single fallen tree that is obstructing one court. Would Piedmont consider re-claiming operations of Davie, thereby adding more tennis courts and possibly space to develop additional pickleball courts as well? That would be fantastic.

Don't like pickleball at all. It's just a new shiny thing. Don't waste my tax money.

friends of mine having mentioned noise complaints

Getting access for tennis has been much more difficult because of this. I have often played at courts in Oakland particularly when summer started.

I also pay for a tennis decal every year and pay to reserve courts frequently. I have been dismayed the Beach Courts were never resurfaced due to lack of money and am not happy to have become aware from an editorial that pickleball plays for free. And I am hearing apparently almost half the usage right now at Beach are not even Piedmont residents. We could have been collecting decal money all this time from pickleball. I also pay facilities fees for my kids sports. This seems so obviously unfair. And now the pickleball community believes they deserve dedicated courts that the rest of us are paying for??!. Why have they gotten a pass all this time by PRD?



Given the communities' interest in both tennis and pickleball, it seems reasonable and fair to design a program that both sports share the Beach courts. Additionally, although my house is not within earshot of the Beach courts, pickleball does create a constant noise for surrounding residences, and therefore sound mitigation efforts should be fully pursued to address this issue.

Good for our seniors.

Having a dedicated courts for Pickle Ball means that the game is accessible to many more players. Many of us are retired and beginner players and we can access the courts now during the day and find courts to practice on without having to compete against the more competitive, advanced players. I have seen very competitive play during the late afternoon hours where every court is being used. It seems fair to have courts dedicated to pickle ball since Piedmont still has quite a few options for tennis courts.

Having dedicated pickleball courts all day (and not just 10am-1pm) allows me to be flexible with my play time and -As a working adult- not being restricted to the morning time is a great improvement.

Having dedicated pickleball courts at Linda/beach is paramount. During the trial it has built community, introduced young and old alike to the game and provided a place for the community to come together.

Having dedicated pickleball courts in Piedmont has made it very easy and convenient for me and my friends to learn pickleball. It makes it much easier to meet fellow experienced players when there is one dedicated location.

Having dedicated space for pickeballers rater than shared court use makes a lot of sense so the community has a reliable place to go and play reguarly rather than moving throughout the city and sharing space with tennis. I believe tennis would prefer not having added stripes on their courts as well and that space has never been a particularly desirable tennis location. Pickleball contributes to connection and vibrance in the community and is quickly becoming a more and more popular way for adults and children to spend leisure time that promotes health. Help support this healthy pastime for our community! Thank you!

Having open courts for extended hours and 7 days a week is far superior to the 3 locations and broken hours we had previously. Now a player can go to the courts w/o prior preparation and almost certainly will find one or maybe many players ready to play singles or doubles. I no longer play tennis so I ignored those questions.



Having pickleball easily available in Piedmont makes a much stronger and safer community. The players tend to be very welcoming and get to know each other and look out for each other. This makes for the kind of town I want to live in and grow old in.

Having recently moved to Piedmont, this has been my primary connection to the community. Friendly, welcoming folks at the courts taught me to play pickleball, and it has now become my primary recreational activity. I'm deeply grateful for the opportunity the volunteers have provided me, and I hope to be able to play here in the future.

Having the courts 2 blocks from my house had made it much easier to play regularly without having to drive in my car to PMS or across town to Bushrod. I have met many neighbors and feel much more connected to my community. This has become more important to me since the pandemic.

Hello. I LOVE having courts at Linda to play pickleball anytime before dusk. The vast majority of the time, others are playing and welcome me/us to join them. My husband and I played five or six times weekly until different injuries temporarily sidelined both of us. These courts are convenient to walk over, and having daily access makes us happy. This is a true, organic community that includes everyone who comes to play. You can't find that often. Look at the hundreds of people who play at Linda to see how well-used this facility is. It certainly is appreciated and enjoyed by many!

How many people are you serving? There is no comparison. Pickleball is the fastest growing sport

I am 77 and very appreciative that Piedmont has made pickleball courts available. At my age there are few vigorous physical sport activities available. Pickleball has provided me with that opportunity. I also appreciate that Piedmont has made pickleball available on a drop-in basis, seven days a week. This means I can play pickleball when I have energy and physically able to do so. A large number of people have told you about the many social benefits that are provided by the sport, as made available by the way Piedmont has and I can confirm that what they have told you about those benefits is accurate.

I am a Piedmont resident that plays pickle ball and would like as much access as possible.



I am deeply troubled by the seeming lack of concern shown towards my Beach court neighbors who are significantly impacted by the pickleball trial and 100% use of the Beach courts for pickleball. It seems clear that pickleball is very popular, and has a huge network of advocates in and out of Piedmont. I see the many letters to the editor, Facebook posts, and other correspondence urging pickleball players and community members to support pickleball at the Beach courts and in Piedmont generally. That's fine, and I have no problem with use of the Beach courts for pickleball. However, use of tennis courts for pickleball must be thoughtful, equitable, and take into consideration what is fair and appropriate for the community immediately adjacent to the Beach courts. Among other things:

- Tennis courts in other areas of Piedmont must be used for pickleball along the same schedules as use of the Beach courts for pickleball - it is not equitable to put all the pickleball in Piedmont at the Beach courts. Pickleball is loud, increases traffic (seemingly significantly), and reduces opportunities to the courts for non-pickleball uses. These effects should be sprinkled throughout Piedmont - not just around Beach.

- Use of the Beach courts should be shared between tennis at times and pickleball at times.

- While the noise of pickleball only impacts my family when we're recreating at the grassy or on the Beach school blacktop (which is often), it's quite loud and constant when we're recreating in these locations. I can only imagine what it's like for my neighbors on Howard and Sunnyside. It only seems fair to ensure that everything to control this noise has been done - I don't see evidence that such has happened. Has a sound study been conducted? What are the results?

- How is PRD dealing with the increased car traffic on Linda resulting from the constant use of the Beach courts for Pickleball?

- If tennis players have to register and pay a fee to use the courts for tennis, pickleball players should have to do the same.

I am in favor of pickle ball at the Beach courts. I sometimes played tennis at the Beach courts, and the space around the courts is very tight for tennis. I am not opposed to either pickle ball only or shared use between pickle ball and tennis.

I am interested in learning pickle ball and what options are available on the Linda Courts. Is there an instructor? Is there a group that I could join?

Piedmont Pickleball is great. The City needs to support it.

The City can convert this 1 court and then should build more dedicated Pickleball Courts.

Pickleball has no dedicated space at all when many in Piedmont wish to play. Not everyone can play tennis as they age.

The City needs to support Pickleball for the health of all its residents.

I am very concerned about the noise from the courts. I want to play pickle ball. I live near the courts, but do not hear the noise. However, I empathize with those who do, esp those who work from home. I believe pickle ball should not be permitted.

I attend PHS and since beginning to go play pickleball at beach have met so many other residents and community members from all ages, genders and backgrounds. It is so cool to see the community that has been built through pickleball. My friend and I are obsessed and love to go for hours at a time, multiple days a week.

I believe that dedicating the Beach courts to Pickleball is the right thing to do despite the loss of 2 playable (but not ideal) tennis courts. As a tennis player, I find the pickleball sound distracting and prefer not to play in the same vicinity. I also believe that having a dedicated area for pickleball encourages the popularity of the sport and is a positive one for the community, especially for those who want to learn the sport. Both of my adult children have played pickleball at Beach with their friends and have enjoyed their experience.

I believe that the constant loud noise coming from the pickle ball courts during the school day have impacted the students at Beach school. I would like a qualified psychologist to see if aggressive and disruptive behavior has in fact increased since the conversion of the tennis courts to pickle ball courts. There are many noise studies that state constant loud noise does in fact create stress and other undesirable behaviors. I ask you, does this community really want to run the risk of damaging our children?



I didn't previously use the courts because I didn't play tennis. I used them a few times once pickleball became available but infrequently b/c I generally was unavailable 10-1 weekdays. Now I can play there b/c PB is an option in the early evening and on weekends.

I've enjoyed playing at this site as it's close to my house so I can walk there. It also seems to attract a wide age range of players. For example, a father and his son stopped by on a recent weekend to learn to play. Two experienced players lined them up with loaner paddles and spent the next :15 teaching them the game. That collegial spirit is one of the many aspects that makes PB unique.

The sport is incredibly low cost, easy-to-learn, accessible to all ages and abilities. The sport makes very efficient use of our limited recreation space. This is exactly the kind of endeavor our rec dept (with its limited staffing, funds and space) should be investing in and optimizing for our community.

Most importantly, pickleball, especially with the open play structure, tournament play, lessons, loaner equipment, and volunteer sponsored pot lucks (seriously?! just incredible) that is unique to Piedmont, offers something that every city woks hard to create: Community. Playing pickleball offers many cognitive and physical health benefits that we all need at every age. But the social aspects of pickleball help combat loneliness and social isolation that many people experience especially after the pandemic. The benefits to our personal and collective mental health are immeasurable.

Lastly, I understand there was a noise study underway and I'm not sure what the results will tell us. But when I've visited the loudest noises I've heard were peals of laughter from groups enjoying each others' company, raucous razzing over poor playing, trash talking over unwarranted competitiveness and other sounds of community members having fun enjoying a sport they love. If that's not what the city and our rec dept are designed to create, encourage and support, then our priorities are out of alignment with what Piedmonters value.

Please do everything you can to support this sport and provide the facilities, equipment, and lessons needed to meet the needs of a growing community of players, young in age and young at heart.

I find Pickleball to be far more enjoyable than tennis for older residents, like myself, and for younger residents, like my son.

I encourage you to continue the Pickleball schedule as is.

I live at 104 Sunnyside Ave in Piedmont, just above the Beach tennis courts. We purchased our home in 2021 and selected this location in Piedmont in part because of the proximity to the tennis courts, toddler sand lot, and beach school.

I would much prefer that the tennis courts behind my home remain a tennis court because:

- a) I have a toddler who now has to listen to pickelball noise, adults shouting etc. whenever we go to the tot lot to play
- b) now I hear pickle ball noise in my backyard for 12 to 14 hours a day every day in my background
- c) the amenities I moved here to access, and pay exorbitant taxes for, have been changed without my consent

I live close to these courts and the negative impact on neighborhood parking and noise is undeniable. I recognize that people want to play pickle ball but this site is a bad option. I lived near the Beach Courts for about 40 years. I rarely saw them used for tennis. Pickleball at Beach is involving hundreds of players. Pickleball is by far the highest and best use of this very limited recreational space in Piedmont. It is entirely consistent with the multiple other recreational uses of this long term dedicated recreational area.

I love being able to go to Beach and pick up a friendly game with friendly people!

I love seeing so many people come to enjoy the pickleball court. But who will pay for wear and tear? The pickleball users should! Even if it's a small fee - they should pay for using the court.



I love seeing young kids and teens playing on Linda Beach this summer, with and without parents as partners. I am an avid tennis player, and Linda Beach was just awful. There is no point in returning non-regulation courts to Linda Beach. Safety is the issue! No excuse for putting an unsafe tennis court at Linda Beach.

Pickleball serves more residents of the community than tennis. It is impressive to see the joy it brings many more young and old residents (seniors) together. I am a tennis player, but it would be a shame if Piedmont favored tennis with eight pristine courts available. If Piedmont does not allow pickleball, I fear our reputation as a community would look worse than it already does.

Five hundred eighty-seven units are coming to Piedmont; it is time Piedmont has ONE sport that is essentially free of cost and integrates all residents. If Piedmont has concerns about diversity and integration, make pickleball happen.

Pickleball is a fun, social sport everyone, young and old, enjoys together. Watch the movie *Invictus* to see how a sport brings a nation together.

I love the community of pickleball players at Linda beach. It is such a diverse group of players. Not that school is out - I love that school age kids are now joining us. It is the only place and game that an 80 year old can play with a middle schooler!

I noticed it was significantly harder to park for Beach school drop off and pick up after March. Looks like a fun sport and I enjoy seeing the courts used but limited hours to accommodate school would be helpful.
It's also a loud sport, so starting later and ending earlier would probably help with the neighbors. Not sure if you saw the recent NY Times article on constant noise pollution but it's been linked to health problems.

I play both tennis and pickleball and enjoy both. I like that pickleball allows more people to play.

I play pickleball often and these courts are near my house. East Bay needs more courts and these would be a welcome addition. The courts need work to be my favorite but I like the reduced noise balls. I often play at Montclair, Oakland. I like the ability to reserve courts. Would this be a possibility here?

I play tennis at Hampton courts. The additional lines drawn for Pickleball was confusing, so I prefer that we keep separate courts for tennis and pickleball.



<p>I presently only play at Montclair because they have the nicest courts: best surface, dedicated lines and nets, etc. everyone is looking for more areas willing to do the same- I hope Linda beach considers making their spaces fully dedicated pickleball courts! Thanks kindly</p>
<p>I really enjoy the pick up nature of pickleball and how you can show up anytime to play a game. I think having exclusive courts is important to maintain this type of use. It's clear that the courts are being utilized far more since the trial began. This is a great use for these courts and I hope they will be used exclusively for pickle ball going forward.</p>
<p>I really want to take pickleball lessons and play in our town. Please give us a chance to try it and enjoy playing pickle ball in our neighborhood. Thank you.</p>
<p>I recommend making Beach courts dedicated pickleball courts as there are other courts dedicated to tennis.</p>
<p>I recommend that the Beach courts be restriped for pickleball play. As a tennis player, my view is that the court surface is no longer suitable for tennis because of pavement defects. In addition, the areas on the side and back of the courts do not provide adequate space. The current pickleball lines are not very clear, so making them permanent and removing the tennis lines will improve the pickleball experience.</p>
<p>I see you are only interested in players NOT neighbors.</p> <p>This is very high handed behavior!!!</p> <p>I am a neighbor I think you should call me. Constance Whitting 510 541 3690.</p>
<p>I strongly believe the Beach courts should be turned back into tennis full time. There is enough pickleball availability at Hampton without the need to add Beach. Further the traffic and parking has been an issue on Linda and surrounding streets.</p>
<p>I strongly support the striping to be made for pickleball use only. The trial has shown that the community is very strong, the players are doing their best to respect the sound and safety concerns surrounding the courts, and the courts, not standard for tennis, are just better used for pickleball, which is a popular, inclusive, fun and low-barrier-to-entry sport.</p>
<p>I support pickleball at Beach. Drop-in pickleball is a wonderful thing and brings the community together. I play more tennis than pickleball (although I enjoy both) and having a designated Court at Beach be just pickleball makes the most sense.</p>
<p>I think Beach should be for pickleball only. It has very high use and serves more recreation to more people than tennis. There are enough tennis courts near by to satisfy tennis needs.</p>



I think dedicated pickleball would be excellent. Other towns like Palo Alto and Lafayette have dedicated pickleball which the community enjoys. I would prefer not to have to drive there for quality courts.

I think dedicating Beach to pickle ball is a fabulous idea. There is great demand and it provides the opportunity for people of all ages to play a fun sport. I play tennis and pickle ball and never have a problem finding a tennis court. Our town can handle demand for both.

I think it is fine to share the courts. If they become only pickle ball, then the more middle class folks will always have to go to the wealthier sections of Piedmont to access courts or go outside to Oakland to get court time. These wealthier people often have country club memberships so they are doubly served. This seems foisted on Baja Piedmont by representatives who live in the wealthier neighborhoods.

It would also preclude Beach students taking after school tennis classes if they have working parents. Many people in Piedmont have au pairs or Nannie's or hired help, but if you can't afford that and you and your spouse both work or you are a working single parent, you can't take your kids to tennis classes after school before 5:30 or 6 and need them to walk to after school activities. one way they can get a break from Schoolmates is thru rec activities. There used to be a van that took kids from school to activities but that was cut from the dev budget a king time ago. It isn't realistic that a child would walk up to the Park courts or Hampton for a class and then wait around unsupervised until pick up or walk all the way home.

I know a number of kids from Beach who will play on the high school tennis team and got their start at Beach courts and then continued with private lessons and camps in middle school. This pipeline to tennis may dry up if the courts are entirely given over to older adults. Again, it seems classist as the kids who go to school at Havens and Wildwood and are from wealthier areas, definitely the Havens kids are, would continue to be able to take rec lessons while the Beach kids with working parents who have no after school care could not.

Lastly, I don't understand why I should have to pay to reserve a tennis court, but people who don't even live in this city can use my local courts for free.

I think it is so great to have dedicated pickleball courts in Piedmont. It does not require extra resources to take time to switch out nets etc. One of the reasons we moved to Piedmont was to have a small community where we could find everything we need within walking or a short distance. It just makes to keep the Beach courts dedicated to Pickleball.

People moved to those homes with tennis courts, playfield, TotLot and School playground in the area. NOT THE NOISE associated with constant pickle ball play, conversations on the courts and cars coming and going. The Piedmont Recreation Department budget is significantly funded by the taxpayer residents of Piedmont. <p>I would stripe beach for pickleball only. But I would like to be able to have a reservation system like the tennis system. As a beginner pickleball player, the only round robin system currently in place creates no where to learn and practice, as the round Robin players are quite competitive and are not enthusiastic about playing with a beginner.</p> <p>Although it may be somewhat difficult to find a tennis court at a specific time in Piedmont, this is impacted mostly by school/camp/group usage. Sometimes it is no problem to find a court. It just depends on what is happening in Piedmont.</p>

<p>I'm a new Pickleball player, and I've felt so welcome at the Beach courts! I love the mix of ages and the pickup structure. It's been a great place to learn the game, and the fact that I can walk 10" from my house makes it that much more fun — reminds me of playing in my neighborhood as a kid. Hope we can keep the games going!</p>



<p>I'm a Piedmont resident and since the Linda Beach trial began my life has changed for the better as I socialise and exercise. Access to these courts is easy with few steps to negotiate for older residents like myself. Please dedicate these courts with the necessary strippings and color to Pickleball only.</p>
<p>I'm a tennis player primarily, but I'm content with the arrangement of Beach court for pickleball and the other 3 courts for tennis. (Beach court has never been a very good tennis court.)</p>
<p>I'm an avid tennis player in Piedmont. I play 4.5 and up in doubles. There has been no change in access to courts. In fact we only Beach as a last resort when the HS teams were playing or camps made it more difficult. We would never choose to play tennis at Beach. However, I am now playing pickleball with a ton of friends who I would never play tennis with. We are having a blast at Beach and a nice community is forming. Way more laughter too!</p>
<p>I'm deeply concerned about the noise impact of 12 hours 7 days a week usage. I have friends who no longer enjoy their decks and gardens in the neighborhood surrounding the courts. Yes it's a fun popular sport. But let us also exercise some basic common sense.</p>
<p>I'm not a pickle ball player but when I walk by, the noise is pretty loud. The players are very vocal and the ball being hit is pretty loud itself.</p>
<p>I'm playing pickleball more often now because it is so much more convenient for me to play just a few blocks from my house anytime</p>

<p>If it wasn't for the Pickleball in Piedmont, I wouldn't get "any" exercise in at all. I've quit the gym during the pandemic and I only walk once a week. But with Pickleball in Piedmont, I try to play almost everyday and I will walk to LB to add to my exercise routine. Please have dedicated Pickleball in Piedmont so I can continue doing regular exercises almost daily. I have lived in Piedmont for over 30 years and am excited for Piedmont to have dedicated Pickleball courts.</p>
<p>If noise is a problem (and I keep reading that it is) maybe the best way is to limit use to a small time window, such as 12 to 4.</p>



If pickleball is a sport (which proponents claim it is), they should have to register and pay a fee equal to tennis. That's only fair.

If pickleball is not a sport and simply a beautiful amorphous community phenomenon (which proponents also claim, depending on whatever argument best suits their interests), then it should not be allocated any use of the limited recreation facilities.

Please do make the noise study public when available. I'm concerned that the courts are so close to the Beach kindergarten classroom and in my experience, the constant noise from pickleball is highly annoying.

I'm a neighbor on Howard, behind Beach! We had been mostly going to Montclair to play, but the Beach scene is so much more fun, and closer! We love it. Thanks for the trial, we hope it will continue.

I'm a Piedmont resident and support permanent courts at Linda. Prior to the trial we had to recruit dozens of volunteers to open, set up, break down and lock up the nets every day we wanted to play. We made it work, but it took a lot of time and energy. Having dedicated courts has vastly improved the experience and has expanded playing time for all. Dual striping is unfair to pickleball players, as we have to do all the setting up and breaking down and still get sub-standard courts with faint lines. We've been told there is no other place to put dedicated courts, so I hope the Rec Commission does the right thing and makes the dedicated courts permanent. Thank you.

I'm an outdoorsy athlete and I believe in offering other means of getting community members to socialize and get outside.

When I bought my house near Witter Field, I was aware that there would be noise from the environs I knew that there would be others who would park on my street. But this reflects the active community in which I live.

I'm concerned about the increased impacts to street parking at the Beach courts.

I'm glad that the tennis courts are finally being used for pickle ball more than before when it was exclusively for tennis use only. It was definitely a waste of space for tennis since they are not ideal tennis courts but perfect for pickle ball.



In response to your survey, I have not played at Beach since the trial began because of a foot injury. I haven't played since the end of February. I would have continued to play regularly (1-2 a week) if I wasn't injured. My hours would have been different, sometimes, playing after organized playing. I would have invited friends to play at my level. I am planning to return in the next week. I am an older adult and if I were younger, I would play a lot more. I used to be a tennis player and I never liked Beach because the spacing between courts. I preferred the other locations.

Today, I took my dog to the dog park and wandered to Beach Courts because I saw a friend playing, I was stunned to see the new people, especially, the young players. They were playing after open play and two to three courts were occupied. One player was 10, playing with his dad. Eventually, they played against two teenagers. It was wonderful. Because I played regularly before my injury I often recognized players on the court. Today, I didn't know anyone except one player. In the summer, very few young players drop in at PMS, but they were playing at Beach. To me, this was a testament to how the Beach courts are bringing in Piedmont kids.

Since the property space is not fit for regulation tennis courts, I think that this is the time to put in permanent pickle ball courts. I don't want to drive to courts outside of Piedmont to play and be restricted to certain hours. I also think that our kids should be able to access courts in their community.

It has been great to have dedicated pickleball courts. I have enjoyed family time with my wife and son and have also met many friendly community members. Thank you for running the trial!

It is a waste to use the tennis courts for pickle ball.

It is important to have easy and ongoing access to Pickleball courts for the increasing population of people who enjoy playing Pickleball regularly. This taps into a population that can no longer play tennis or was not interested in tennis previously. It provides exercise as well as social opportunities both of which are so important to positive mental health. I hope this becomes a permanent part of our community, using this real estate to maximize usage to the most number of people who can benefit!

It is truly incredible to see the crowd that gathers to play pickle ball at the Beach courts. This sport is getting the community out together and helping people connect and stay fit. I hope the Recreation Commission helps this to continue by turning the courts into full-time pickle ball.

It seems as though these courts are getting much better use as pickleball courts, and the community on the courts is awesome -- friendly and welcoming.

<p>I've lived in piedmont for over 60 yrs. I learned pickleball in piedmont in 2019 and since then, have played every week in Piedmont. I've met so many neighbors that I would have never met if it wasn't for pickleball. Although our kids have graduated from the Piedmont schools, my husband and I do not want to move out of Piedmont, for the pickleball community we've become a part of. The sport has become so popular, that the need for dedicated courts is great. Having to share pickleball courts with tennis is not fair as, the growth of pickleball is greater than tennis. Having dual lines is not easy, as we often confuse which lines are what. Pickleball is a sport for all ages and abilities, it's a very open sport and easy to pick up. I'm all for dedicated pickleball courts at Linda Beach. Thanks for allowing the trial to show how impactful having dedicated pickleball courts at Linda Beach could benefit the Piedmont community!</p>



Just like politics and work, you will almost never get a 100% consensus due to the wide differences of opinions, so please consider what the majority of people prefer and do the right thing and not give into the few (1 or 2) homes who are against having dedicated pickleball. You need to consider the future of Piedmont and it's residents with regards to the tremendously growing popularity of pickleball all over the country.

Please don't give Piedmont a bad rap about not having any dedicated pickleball courts. I would hate to take away from the "official", dedicated tennis courts for a dedicated pickleball court when Linda Beach tennis courts are not "tournament" tennis courts sized. Better to take under-utilize and smaller courts from Linda Beach for dedicated pickleball courts instead or other tennis courts in Piedmont.

Keep Pickleball in Piedmont!

Keep the courts pickle. It's a great thing for our community

Linda Beach courts are wonderful. They are walkable from my home. The community is very kind and welcoming.

Living near the courts on Linda Ave, I listen to the repetitive sound of the paddle hitting the ball. I know efforts have been made to mitigate the sound but it hasn't worked. The sound is still invasive, not natural and repetitive from 9am until the last players decide it's dusk. The noise from pickleball daily disrupts the entire Linda Ave and adjacent streets. It's constantly in the background when trying to enjoy a morning cup o' joe on a Saturday morning, when trying to meditate or nap during the day, when eating meals, when trying to read. It's an unnatural sound that is an extreme change to the existing neighborhood conditions for the past few decades (and probably even further back). It's unreasonable to expect the neighbors, particularly those who are sensitive to the noise from pickleball, to ensure this loud, unnatural sound for up to 12 hours per day. Please reference a recent NPR article regarding the impact on people's lifestyle and peace of mind. Again, it's an unreasonable expectation to ask neighbors in the Linda Ave area to live with this noise 12 hours a day, every day.

Lots of traffic and crowded- noisy during the day. Maybe decrease the number of courts for pickle ball. Also make tennis available. Perhaps keep one tennis court open.

<p>Love the Beach pickleball courts! I live close by and I see them being used all the time. I would be very disappointed. If you didn't keep them, they are used by people who would never use the courts for tennis.</p>

<p>More and more families with kids and teens are playing since school is out. Keep the community vibe going. We do not want to intrude on the other pristine tennis courts; we just want a place in Piedmont to play pickleball.</p> <p>Pickleball scholarships for college are now in place. Let's move with the crowd and give our children a chance to excel and win scholarships for pickleball. Move with the times!</p>
<p>More permanent courts will help the sport continue to grow and make the community stronger.</p>
<p>My family frequents the playground/fields at Beach and my young daughter will enroll at the school next year. We have been present when the pickle ball players were using the courts. I have serious concerns about the noise impacts on the children at Beach. Average noise for pickle ball is ~70dB, which is almost twice as much as average tennis noise (~40dB). This noise pollution is a known issue with pickle ball and even covered on sites dedicated to promoting the sport. According to a recent NY Times article, there are significant deleterious effects on health and stress hormone levels with prolonged exposure to noise (https://www.nytimes.com/interactive/2023/06/09/health/noise-exposure-health-impacts.html?smid=nytcore-ios-share&referringSource=articleShare). As a member of the community, a concerned mother, a physician, and a taxpayer, I am strongly against placing a permanent pickle ball court adjacent to a school or allowing any play while school or after-school activities are in session because of the aforementioned health impacts. Thank you.</p>
<p>My family gives PRD a lot of money for different programs and it is so good that pickleball courts are available outside of Saturday morning and afternoon.</p>
<p>My house is very close to the Beach courts. While I am supportive of Pickleball as a sport, the constant noise from the courts is extremely annoying even when the doors & windows are closed. It has led to disturbance in me and my husband's work, our daughter's nap time and evening story time. We have completely stopped using our outside deck because of the noise..</p> <p>Will very much appreciate if you could atleast limit the pickleball activity so that we can go back to enjoying our home in Piedmont.</p>



My husband and I recently bought in the area and were very excited to see (we thought) tennis courts a five minute walk from the new house. We were disappointed to see they'd been repurposed exclusively for pickle ball. We're happy to schedule when we play tennis around court availability if there's shared use, but it's highly inconvenient if the nearest courts are exclusively pickle ball.

It looks like the Piedmont Park and Corey Reich Tennis Center tennis courts are rather close to one another; it's confusing why one of them wouldn't be a better choice for pickle ball so no area loses access to easily walkable tennis courts and we all gain moderately to easily accessible pickle ball courts within Piedmont.

My kids both went to Beach and I know the area well, and my son played PHS tennis so we also have experience with all the tennis courts around town. Pickleball at Beach is a wonderful upgrade to the town. The courts there do not play well for tennis, and we need access to pickleball in Piedmont! It's the fastest growing sport and a great option for those over 45 (of which there are many in town). I only wish your survey had a question about intended future play. I have an injury right now... so my expected future use of these courts is high even though it's not right now.

No Pickleball please. They take over and are not collegial. It is loud and there are many people who never want to leave. Unfair.

On several occasions during the trial, we couldn't play tennis because the Rec, Park and Hampton courts were full due to summer camps. This is when we most need Beach courts for tennis. If there were a way to split the Beach courts so they were available for tennis when camps take over the other tennis courts and pickleball during the afternoons and evenings, that would help address the problem.

Parking for student pickup and after-school activities has gotten next to impossible with the number of cars parked for Pickleball. Most of the people playing don't seem to even be from Piedmont! The current situation is not sustainable, regardless of your feeling about the sport played on those courts.

Parking is a now a problem for camp/school pick up near the courts/beach field and for the resident parking on Linda. There is also unpleasant constant noise that is heard from the pickle ball courts. It should be studied whether the elementary students can hear it through their classroom windows as the sound frequency is very irritating (recent NPR article on this topic of pickle ball sound frequency as well)



Parking is going to be a nightmare by the Beach courts once school is back in session-it was already challenging. I've never had difficulty parking near the Park or Hampton courts. Is using half of the CR courts for pickleball a consideration?

Permanent dedicated pickleball courts at Linda Beach are the best way to address enormous (pre-trial unmet), growing demand for pickleball in Piedmont with the lowest impact to tennis, which will still occupy eight times the dedicated court space to meet demand roughly equivalent to pickleball. The PRC does not have a good alternative to address pickleball demand. Limited hours at poorly lined shared courts with flimsy temporary nets across a few venues is unfair to pickleball's popularity within Piedmont.

Parking for Linda Beach Elementary is better than at any other school in Piedmont so should not be considered an issue, as multiple checks have confirmed. Plus there are ways to improve it if needed. It's hard to see how safety would be impacted by some 25 pickleballers gathering at a venue like the park, which can host well over a hundred people for major events.

We should be open to the results of the sound study, but the experience of players who live adjacent to the courts (as well as my own) is that the noise from pickleball does not add significantly to the noise levels around the park, and it is often drowned out by louder noises such as traffic and kids' sport teams. The use of a quieter, lower-pitched ball has mitigated any impact, and sound measures may help further.

A small number of neighbors have complained about noise, I understand, including one household especially, which has submitted daily complaints. Prior to the trial, this household was already effectively leading the opposition to dedicated pickleball courts, focusing on the loss of tennis from the neighborhood. It's worth noting that they cited noise as an issue -- and an extreme one -- only after the trial began, even though pickleball had been played at Linda Beach for four years prior to the trial beginning, including during the pandemic, when children were at home. Indeed, despite then-opponents' worries prior to approval, no noise complaints were received about pickleball during four years of part time use .

Please be careful about being overly influenced by a few people reporting noise issues, which may be unrepresentative, or because they are subjective and hard to dispute. Please also be cautious with petitions that neighbors sign to support their neighbors rather than because they are experiencing issues themselves. We should rely instead primarily on the results of the noise study and pay attention especially to the incremental impact of pickleball sounds in an already noisy park -- one that residents moved across the street from knowingly, understanding that the activities and associated noises from the park would change over time.

Two Linda neighbors -- an elderly couple who play tennis -- recently described the advent of

Many of my friends live in communities where they have full time Pickleball courts and I hope our Piedmont community will do the same.

Pickleball has made a huge difference in my life to bring community, joy, fun, and fitness. I meet so many great people and love the way everyone can play together. It's an amazing use of public space— there's nothing like it for so many people to have so much shared enjoyment in a small space. I can play so much more because I can flexibly fit pickle into my life as a parent, student and worker with the court open hours. We're happy to do whatever to accommodate noise. I hope that the city of piedmont will keep the courts!!

I know the noise has caused problems, and balancing community needs is a nearly impossible and thankless task (so, thanks!). My hope is that the value of this wonderful community can be preserved, and that we get a chance to do whatever fundraising is necessary for noise abatement tools so that we can keep this beautiful thing going!

The court should be improved and shared.

The courts are much better sized for Pickleball than tennis and I believe that the number of Pickleball users justifies upgrading the courts for Pickleball. The concern for noise is overrated as there is already the school, preschool play area, sports field and dog park that all are used by the community and have been for ages and all contribute to noise as the community uses the area.

The courts are too loud for neighboring houses as well as the tot playground.

The courts at beach are unplayable for tennis. We tried it a couple times but it's too tight and honestly dangerous (due to the unevenness). The data shows it: there's high demand for pickleball in Piedmont. It all comes down to equity: how many DEDICATED pickleball courts are there in Piedmont? How many tennis courts are there in Piedmont?

The dedicated courts make it much easier to drop in and play pickle ball. I've met a number of neighbors and new members in the community which was more challenging with small windows of temporary pickle ball court access.

The pickle ball community continues to grow and we need more access to courts. Having a dedicated space is wonderful. Please keep the Beach courts for pickle ball and improve the courts to add even more space.

The demand for tennis courts at Piedmont has not diminished over time. The Piedmont community need as much access to tennis courts as it has for a long time. I completely respect the need for pickle ball players to have access to courts as well but to provide that by taking away court time or access from tennis players does not make sense. As a community we need to find a way for pickle ball and tennis players to share facilities without blocking one group in order to provide for another.

The LB courts are used more now than I have ever seen. The loud noise pickle ball creates for residents that live within ear shot of the courts, is annoying! I do not want pickle ball to be played at this court location EVER! I do not like how historically the City of Piedmont punts activities down to Baja Piedmont. Share the wealth and let pickle ball only courts to be in upper Piedmont only, for there are far less residents that it will impact like it does at the Beach tennis courts.

The pickle ball courts at beach strengthened the piedmont community. It allowed the space for piedmont residents as well as others to come together and bond over their common love for pickle ball. Since the trial began, I have found myself highly more likely to go outside and mingle with others because of the trial court. Pickle ball is a sport that includes and involves everyone. With the addition of permanent pickle ball courts at beach, the community as a whole as well as individuals would improve greatly.

The pickle ball courts have greatly reduced my 11 yr old's time to play tennis. He can't play with me or his peers as there is very limited availability at other courts in Piedmont. Meanwhile the parking around Beach Elementary was extremely busy. Making pick ups and drop offs harder. Further more the noise from the courts could be heard at Beach during the school day.

The pickle ball courts took up one of the tennis courts, but the other tennis court could be used early in the morning before pickle ball started. I went by to hit tennis balls with a friend and the net was removed. Was this done by parks and rec?



The pickle ball players has made the parking situation around Linda terrible on the weekends. The kids sports games already make parking difficult and when you add in the pickle ball players, we are having to park way past Beach school to attend the elementary school sports practices and games. It makes things more difficult for parents hauling multiple kids and equipment. I assume the people who live on Linda don't like the additional congestion either. I'm not opposed to pickle ball per se, but I do feel like it adds a lot of strain to a residential neighborhood that is already pretty busy due to the sports field and the school.

The Pickleball courts are a great thing for seniors exercise, recreation and social interaction. I'd like them to be available for play as much as possible!

The recreation ("sport" is too strong a word) shows no indication of decline so the city should continue to support ("encourage" is too strong a word) its use. That, having been said it is concerning that this survey asked none of the questions that would foster a real dialogue to insure harmonious adoption:

For example,

"Has the noise level been an issue?"

"Has parking been an issue?"

Etc.

The sport of pickleball has brought to Piedmont a way for players of all ages to come together on an ad hoc basis to enjoy a satisfying and vigorous form of exercise. Prior to the beginning of pickleball in Piedmont, senior citizens had little opportunity to come together for outdoor exercise. The trial period at the Beach courts has demonstrated that a fixed location has the ability to satisfy the needs of both senior citizens and an increasing number of younger players and to do so in a way that brings these two groups together in a manner that no other sport can offer. The Beach courts are marginal, at best, for tennis, and other tennis locations in Piedmont well satisfy the needs of all tennis players, including those who live near the Beach courts. As a center for all sorts of outdoor activities (tot play, soccer, etc.), the addition of pickleball to the recreational mix at this location is in keeping with its previous use, and the issue of the sound of the game seems to have been manufactured by a very small number of residents and is clearly contradicted by others similarly situated. I sincerely hope that the Commissioners will do the right thing by our community and give pickleball a permanent home at the Beach courts.



The trial at Linda Beach courts has revealed the diversity of interest and engagement in pickleball in Piedmont. Folks from age 10 to 82, and from many different cultural backgrounds, play regularly -- and together -- in what feels like a true community activity. The demand for pickleball facilities is enormous, and Piedmont is in a position to help meet that demand with dedicated courts in this location. Everyone at Linda Beach is committed to using the reduced-noise balls and respecting the parking rules related to school activities. We hope the Commission can recognize what a significant opportunity there is to continue to support the community building that pickleball affords Piedmont and to commit to creating permanent courts in this location for this burgeoning and inclusive sport!

The trial period has proved to be a much better utilization of an under-utilized sport field in Piedmont. This is a great outdoor activity that seniors can easily participate in.

There are lots of options for mitigating sound on the courts. That should not prevent hundreds or thousands or residents from using the courts!

There are no permanent pickleball courts with daily access available in Piedmont. This sport is growing and provides valuable opportunities for fitness, exercise, and mental health to the population. I'm very much in favor of having Linda Beach become a dedicated pickleball facility able to support the needs of the community. Thank you!

There are, without any doubt, more players on the court when pickleball is being played. (4 courts vs 2 courts) Pickleball is mostly a doubles game.... So 16 players at a time in 4 courts, vs tennis which is most often played in singles style. Please dedicate these as PB courts, since Piedmont already has dedicated tennis courts! Seems only fair. Happy to pay a token medallion fee per year of this means permanent courts and permanent nets!



There have been countless times that the courts are completely empty. If the courts were shared, the tennis players would be able to pop in on days the courts are empty. There is also no reason that pickleball should have special treatment when it comes to not having to pay for a decal and to reserve a court. It seems as if the tennis community is being discriminated against and having to carry the financial burden that pickleball doesn't have to. Finding courts that are open has become extremely difficult since Piedmont has decided to ignore the Baja Piedmont tennis community and make a decision that impacts the families of Baja without any consideration of asking or taking a formal vote from the families. Over 50% of the pickleball players don't live in Piedmont. So the Piedmont tax payers should have to have our tax dollars subsidize the pickleball community that don't live in Piedmont??? This argument about pickleball being the fastest growing sport in the country is ridiculous. Soccer is as well. Maybe we should make the grassy an exclusive soccer field and not tell any of the families it is happening until 3 weeks before it happens. The execution of the pickleball plan was poor at best. If pickleball doesn't have to pay for decals and reserving courts then neither should the tax paying tennis community of Piedmont. I've never had a problem with the taxes here because of the community it benefits but you have taken away a facility that I used and many families did as well to service a community that largely don't even live in Piedmont. Ridiculous to say the least. There is absolutely zero reason why these courts can't be shared. Let's not even get into the noise it creates. The proximity of the noise to the sand lot where babies and toddlers play is also a huge problem. Decibel levels of hard hitting pickleball noise can be bad for the developing hearing of children. No one polices the paddles used. There are players that show up with paddles that are extremely loud. One last point is that now that the grassy has summer camps, the parking is a nightmare when the courts are used. I had to park a block away to pick up my daughter from camp everything. If I'm being honest it feels like Piedmont doesn't give much consideration to the families that live below Grand.

There is a large population of pickleball players in Piedmont and no courts striped only for pickleball. By contrast, there are many other courts striped for tennis. While everyone would like more facilities for their preferred sport, Piedmont has limited space and it must be shared.

There is a lively and growing community of people who played pickle ball at the Linda Beach courts. People are friendly and welcoming, and there is a range of ages of. people who participate. Enhances the comederie....

There is a shortage of tennis courts in Piedmont. Kids, esp in the summer and fall, on the high school tennis team, cannot practice. We are commuting to Moraga to play these days. Even a ball wall down by Beach would be some way to practice. Now there is no option.

This summer it has been very difficult to get a space in Piedmont tennis courts during the day when it used to be easy to find time on the Beach Courts. My daughter did enjoy the pickleball lessons at Beach. But my son loves Tennis and would as a family we would be much better served by a court that allows both sports to be played.

This survey does not seem to be interested in how the change of schedule impacts those of us with a house on the courts edge.

I want at least a day or 2 of freedom from the noise of pickleball hits.

I want to be able to have guests to enjoy my deck space without having to contend with pickleball hits to hear each other.

I also want to know what happened to the bocce ball court idea that was proposed before covid. A Bocce ball court was to be in the space you are discussing. I was very happy about that prospect. Something I could enjoy at last included.

This trial is brilliant and these courts were an under used city facility. We live very close to the courts and our neighbours are very positive about the program. Thank you.

To my knowledge this is the only place to play Pickleball in town during the week. It is always crowded which shows the demand for the courts and is a sport that all ages and levels of ability play. This is the best thing that has happened to me since Covid- getting me physically active, outside after now working from home, and allows for new social interactions which helps with my mental health. Please keep these courts open for the benefit of me and our community.

Too loud. Need hours scaled back. Obnoxious sport

too much car traffic and noise next to beach school now that larger number of people using the courts for pickle ball. this is a safety hazard for the kids, a noise problem for the kids at school, and removes a lower Piedmont place for tennis play. a more appropriate place for pickle ball would be at the Piedmont park courts, or the city can establish a dedicated pickle ball site, say at coaches field area. also, why don't the pickle ball players have to pay for a decal like tennis players do? all around, this new concession of the beach courts to pickleball seems unfair and problematic in how it was conducted.



We are Piedmont residents. Our 17 year old is a tennis player and pickleball player. He plays on PHS Varsity, assists with coaching tennis clinics taught at the CRTC courts, and has been playing pickleball in Piedmont since it was first introduced there at the Park courts. The Pickleball community has been wonderful for our family. Dedicated Beach courts mean we can play pickleball as a family as the court availability would work with our busy schedules. Our son's goal is to go pro, we have been driving him from Albany, Berkeley, Oakland and Walnut Creek since he was 8 so he could get in some good play. Dedicated courts at Beach means he can play there regularly, just like he is able to regularly play tennis at CRTC. The social aspect of it has been great! Thank you for running the trial. It would be exciting to keep it going. We know of more and more youth who are interested.

We are seniors living in Piedmont and very much enjoy having a full time facility for pickleball. Playing pickleball is both healthy for us as seniors as well as socially connecting us to a supportive local community. We would very much like the courts to be dedicated to pickleball so seniors regularly have a place to play. Thank you

We have a limited amount of courts in Piedmont. The Beach courts are walking distance from my home. The courts aren't in the best shape but the fact that they were booked so often despite that speaks to how in demand the courts are. When Beach was closed for pickleball, I had to drive to Hampton field instead of being able to walk to my community courts. There can be some other space that can be utilized for pickleball players, like indoor retail space from the stores that have closed or offices that are downsizing and are giving up their leases.

We have found the pickleball courts to be an incredible asset. The Beach courts were not great tennis courts -- I always picked to play tennis at Corey Reach or Hampton Courts. But having the beach courts dedicated to pickleball has meant that we can easily find free courts and we have played many times as a family. The kids love it and it has been a great positive for our family! We hope that they remain pickleball courts!



We live just behind the courts and frequently utilize the tot lot next to the courts. The courts have become incredibly noisy during this trial with the constant ball popping noises all throughout the day. The players have tended to be more competitive and shout or use profanity which is really not appropriate with all of the toddlers next door on the tot lot and at school. I understand this is a popular sport but it has negatively impacted those who live nearby as well as those who utilize the tot lot. Please consider creating a better balance of both tennis and pickleball or moving the pickleball courts to another location. Thank you.

We would like our tennis courts back, please return them to the way they were

While I am not a very frequent pickle-ball player, I do enjoy it immensely and plan to play more. It is a great game and unusual in that it allows people of all ages and differing abilities to play together. Our society needs more of such opportunities. PG is not a "flash in the pan" fad-sport. It's here to stay. I think Piedmont should dedicate a set of courts exclusively to PB, and Beach is just fine (even though it's personally less convenient for me than being able to play PB, as in the past, at Hampton). I'm around town quite a bit every day and mostly the other tennis courts are empty, so we can't claim a supply problem. People who claim that probably just want their personal convenience of playing at Beach to continue. Yes to PB only at Beach!!! And, should this occur, please redo the surface to maximize the number of courts available. More than 3 could easily fit! Thank you.

While I haven't played much pickleball recently, I'm excited about the courts and would love to get out there and play. Please keep them!

While I like tennis, I love Pickleball and play it much more often (several times per week). All of my friends have turned to Pickleball and I suspect the courts will be used more often if they are dedicated to Pickleball. I would rather see the courts used for Pickleball. If it should be shared use, it would be nice if at least one court can be solely dedicated to Pickleball as the multiple lines are confusing.

While I physically can't play pickleball, I'd really like our children to learn as I believe it is a fantastic social sport with future hopes of scholarships being created for the kids, so best start now. They have played it in gym class already.

My folks have been playing pickleball for over a decade (also avid tennis players), and it is a great community sport.



Who is the commission soliciting feedback from—piedmont residents or the general public? I think feedback should only be considered from verified piedmont residents, as we provide the funds and tax payer dollars for these courts.

My hypothesis from walking by the courts daily is that the majority of people are from outside piedmont (ie Oakland). The courts should foremost be meant to serve piedmont residents and I don't think that is reflected given the question of where you live is not part of this survey.

My desire is not to subsidize other peoples pickleball use with my property taxes, particularly when I am not able to play tennis (mixed use) as a result.

Furthermore, non-Oakland residents should pay for use.

As a tennis player, I have many places to play in Piedmont, or oakland. As a pickleball player, my options for dedicated courts are few. I travel to Walnut Creek, alameda, and have gone as far as Concord and Mare Island to play. There is always a wait to get on the courts, and I often see the tennis courts empty.

Pickleball is a very welcoming sport for young and old. But what makes this more appealing is that you don't have to have a person or a group prearranged to play with like you do with tennis. You can go solo and rotate in with people of all levels.

It is easier on the body than tennis and I have to say, I have much more fun playing pickleball than tennis and I find it just as competitive while being fun at the same time. Dedicated courts would benefit the community, reduce waiting times, and make it so people wouldn't have to travel far to get in some games.

Because I play both tennis and pickleball, I would like to see the courts return to a shared space.

Dedicated pickleball courts are really in high demand. It would be great to have Linda Beach serve the growing pickleball community in Piedmont and surrounding areas.

Dedicated pickleball courts at Linda Beach would be a great asset as so many more people are playing now, including a lot more children.



First, thank you for the trial, the monitoring, this survey, the various meetings, and all of the follow-ups. I appreciate the thoughtfulness that's going into this process.

What I hope for: I would so much like to see LB go pickleball only, with resurfacing & dedicated striping, and with clear, easy-to-remember, extensive hours.

Reasons:

1) In Piedmont, I played/play at Piedmont Middle School, Hampton Park (why did this option disappear? I loved playing there!) and at Linda Beach. In none of these venues do we have dedicated pickleball courts. I would really love to play on some pickleball-only courts. Yes, your eyes adjust in some senses, but in others your brain/judgement is thrown off as you make split-second instinct decisions on playing balls.

Imagine playing basketball on a court also lined for ice hockey and tennis. It's like that.

Dedicated courts/striping somewhere in Piedmont would be so appreciated.

Note: I also play at Bushrod in Oakland (most often), Montclair (semi-often), Richmond (semi-often), El Cerrito (semi-often), Bay Club SSF (occasionally), and, now, whenever away from home. The only places I've ever gotten to play on dedicated courts are Bay Club and when traveling. When traveling, it is MUCH more likely that there will be dedicated courts — Denver, CO; Oahu, HI; Olympic Valley, CA; Ludington, MI, to name just a few. The Bay Area is way way behind, and we could really use some dedicated courts.

I've heard that there may be some Piedmonters under the (mistaken) impression that "people are coming in to play on OUR courts" — I say mistaken impression be/c yes, residents of towns other Piedmont play on Piedmont courts— but everyone plays everywhere! And Piedmont residents are also actively playing on Oakland, Berkeley, SF, El Cerrito, Walnut Creek, etc etc courts. People follow the game.

2) Having a dedicated space with easy, clear, extensive hours, as we've had during the trial, is so helpful as one juggles work/volunteer, family, life commitments— one can just show up, without having a ton of planning having to work out perfectly ... so it supports the emotional and physical health of players; and well-being is a great community value.

3) I'm aware, from things tennis players have said, that the LB courts aren't regulation — either the courts themselves or the play area around them. To me, this is another reason to go pickleball-only.

4) I hear a rumor of a pickleball-paddle cover or new surface that basically silences the paddle-ball contact — ? Problem solved?!

5) I'll close again with thank you. Since picking up pickleball last October, at age 60, my life has been revolutionized. I haven't been this active or this engaged for years. The random, mixed social contact in pickleball is so sorely lacking from most elements of life now. Please understand that when pickleball is supported, community contact and real, human, affectionate bonds among otherwise-strangers are also supported. Pickleball brings people together.

Hi there!

My wife and I are relatively new to the neighborhood—we moved just two years ago. Since then, we've discovered the sport of Pickleball and the incredible community surrounding it that's become established in Piedmont. The pickleball community here is now our very favorite thing about where we live.

We're a couple in our thirties and have made close friendships through the sport with community members spanning backgrounds and the decades. It's routine for us to play (and laugh, as you always do in this game) with 85-year-olds and 6-year-olds alike on any given day. Never in school, workplaces, or with other hobbies have we had the privilege of being a part of such a diverse, welcoming community with a shared passion. Better still, it all centers around being physically active, positivity, and encouraging one another.

We're incredibly disappointed to hear that an outspoken few are pushing hard to stop the conversion of Linda Beach to permanent pickleball courts. Linda Beach is the primary space in which we play—the gathering place for the already large and growing community—we two are there every afternoon! We're also a bit puzzled that noise seems to be the primary complaint. As you, of course, know, these courts are located between a school and a highly-trafficked sports field and across the street from a dog park (that we also frequent). The noises from kids' cheers on the field and dogs' barks across the way have been there for years. When approaching Linda, we can hear them long before the tapping of pickleballs.

Those who live within earshot of Linda have chosen to live among noises from the surrounding amenities. Anyone with a genuine intolerance for such noises surely wouldn't have moved there in the first place. Still, we appreciate that it's natural to be change-averse and protective of one's property, and we're taking actions like using quieter balls and paddles to minimize any impact that our activity's different type of noise may have.

It's tough to imagine a public space with higher utility than the Linda Beach pickleball courts—dozens of community members are spending hours on the courts every day. With how quickly the sport in general, and our local group of players in particular, are growing, we need as many courts as possible. And, Linda Beach is a perfect location—so many of us bike to the courts, and I love that I can jog there from my home as a warm up.

We've heard that those opposed to the courts have been contacting the Recreation Commission frequently. We appreciate you thoughtfully considering all expressed viewpoints while also being careful not to reward minority "squeaky wheel" behavior at the expense of the greater good. Especially when looking at the medium to long-term, I am certain that moving forward with the permanent courts will be a net good for the City of Piedmont. Us humans are remarkably adaptable: Even if the "tap tap" of pickleballs is audible at our neighbors' properties amid the barks and kids' cheers, it will cease to be noticed over time. On one side, we have, for few people, a modest perceived negative in the short-term that will



turn neutral in the long-term. On the other, we have an immeasurable positive (community, unlikely friendships, exercise, fun!) for numerous people, the magnitude of which will continuously increase as more of us pick up paddles and friendships deepen.

Thank you so much for taking the time to read this and for taking seriously just how important this is to those of us who plan to stay in the neighborhood for many decades. We invite you to come out to the courts and join us! Balls and loaner paddles are always available, and teaching the game to newcomers is as much a part of Piedmont Pickleball culture as is laughing after each point with would-be strangers.

I am a fan of both tennis and pickleball, but I think it best to convert Linda courts to Pickleball only; the space for tennis does not allow regulation size courts, and both sports would benefit from having dedicated, properly marked courts.

I have visited the Linda courts many dozens of times. It is typical to see 16 pickleball players of all ages, shapes and sizes keeping each of the four courts constantly filled, with benchwarmers waiting their turn at the sidelines. I believe dedicated tennis players will be better served by well maintained, high quality, dedicated courts at another location.

I am a member of the Oakland Hills Tennis Club, where permanent courts have been installed for over three years. Permanent courts make a huge difference in the quality of play because of the consistency of net height. I would not expect tennis players to use temporary nets.

Pickleball brings together people for active competition and friendship. Please enhance this community by building a professional facility.

This makes it hard to find courts to play pickleball and feel we belong in community life. Hope you find that embracing diverse team sports is healthy for everyone in the community! Thank you!

I believe pickleball is the best thing that has ever happened to seniors and all folks of all ages. It's a fun activity and a nice environment to socialize and meet people. I play 3 to 4 times a week because it keeps me in physical shape. At 70 years old, I feel better than ever due to pickleball because it's a cardiovascular activity. There are no dedicated pickleball courts in Piedmont -- yet it's the most popular sports everywhere in recent years. I didn't use the court because I am brand new to Pickleball. I love the sport, it is a way for older adults to stay active and healthy. It also offers a wonderful way to combat isolation and socialize with other players. All wonderful health benefits. Thank you for this trial and I hope it continues.

I discovered pickleball at LB courts before the pandemic and was instantly hooked on the game thanks to the warm, welcoming and inclusive individuals forming this incredible PB community. I enjoy walking to the courts since I am an Oakland resident living just a few blocks away. Unfortunately, I haven't played for more than a month due to family matters but I miss playing and seeing all my PB friends and meeting many new younger and older players. I am looking forward to coming back on the courts as soon as possible. I sincerely hope that the Commission will understand how crucial pickleball can be in building a vibrant, diverse, physically and mentally healthy community (so needed in this day and age) and will see how the benefits of a permanent pickleball site outweigh any hindrances.

I earnestly hope these courts become permanent dedicated pickleball courts in the future! The congenial community that has arisen around these courts is absolutely delightful! Young, old, and in-between play side by side, given the agreeable rotation system and color-coded ranking. Hopefully, the open play system will not be upended by a more exclusive pay-to-play or reservation system. Let's promote this inclusive vibe that has been created on these courts!

I enjoy the Linda Beach courts because they are dedicated (meaning not shared with tennis) and I can come anytime and there are usually people there to play with. This is very helpful with my schedule.



I experience the PB courts as a unique opportunity to meet and make connections with people of all ages. These have been significant, life changing connections. The open play nature of PB is vastly different from a making reservations system and creates the community building.

I feel more useful to setting up for pickle ball since there are more people show up playing pickle ball most of time.

I found out about this while on the bus riding by the Beach school pickleball courts. So a few days later, I got off the bus there and asked someone who was coming out of the court about it - whether anybody could play, whether it was a pickup game, or if I needed to bring someone to play with, etc. She was kind enough to encourage me to play, and told me where I could get a racket. She told me there is a white board where you write your name while you're waiting to play, and that it's a pickup game, anybody can play, it's free, you don't need to be part of a special group, or sign up before coming, or pay to play. So I'm thinking of buying a racket and trying it there. Also, some friends of mine play basketball on some weekday evenings at Beach school, so maybe I'll go at the same time they go.

I think it's wonderful that you make these courts freely available to the community. I haven't tried it before but have been hearing about it since before COVID. I like playing ping pong and Beach school is closer than any ping pong place in Oakland, which I haven't done since before COVID. Tennis seems like a little too much running for me (I'm 62) and my brother got hurt (not in Piedmont) falling when he was running playing tennis, so pickleball might be a happy medium between ping pong and tennis.

I've observed that a lot of people are playing pickleball there around 5pm on weekday evenings.

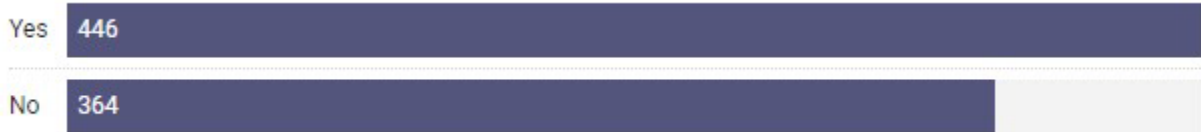

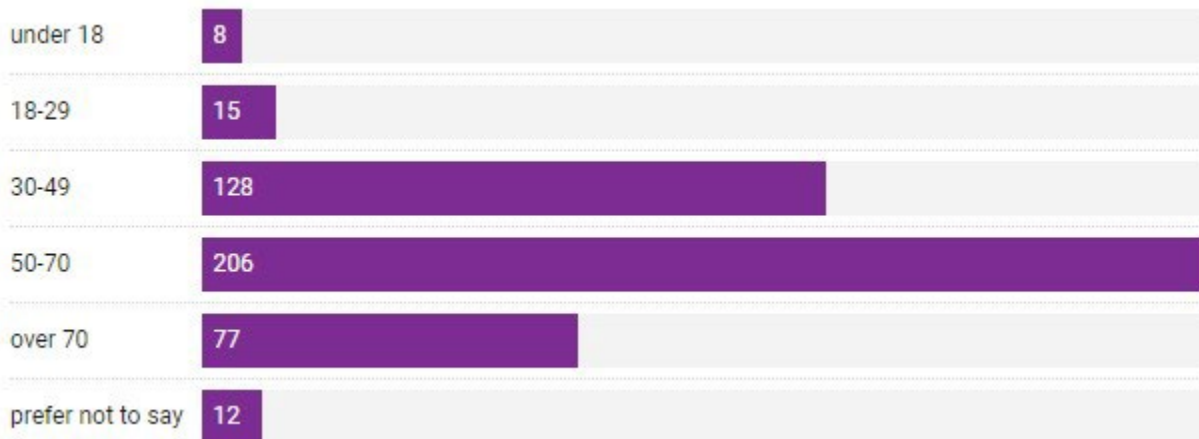

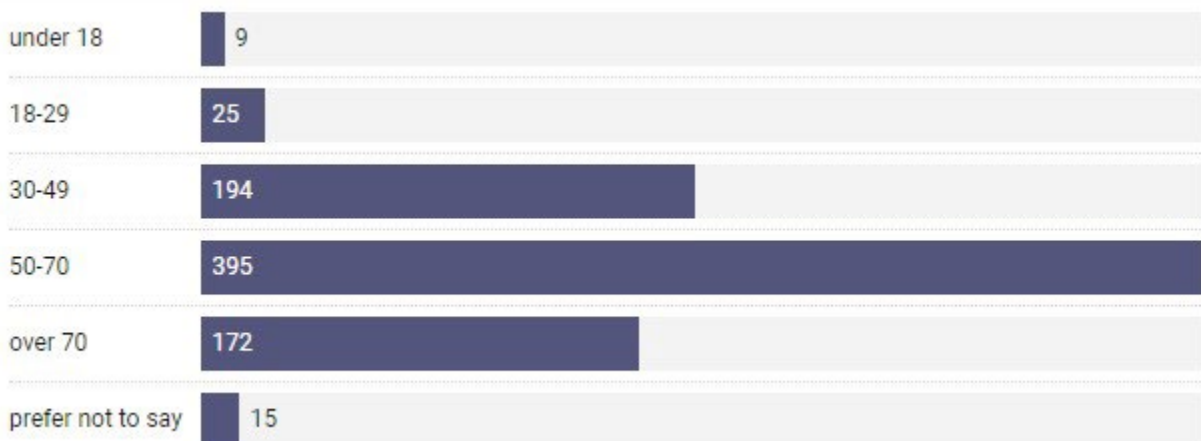


What best describes your age?

Piedmont City Code - Chapter 12 OFFENSES-MISCELLANEOUS

7. SEC. 12.8 NOISE DECLARED NUISANCE Notwithstanding any other provision of this Code, and in addition thereto, it is unlawful for any person to willfully make or continue or cause to be made or continued or to allow any animal to make or continue to make any loud, unnecessary, or unusual noise which disturbs the peace and quiet of any neighborhood or which causes discomfort or annoyance to any reasonable person of normal sensitivity residing in the area. Such noise is declared to be a nuisance.

8. 12.8.1 Standards to Be Considered. The standards which shall be considered in determining whether a violation of the provisions of this section exists shall include, but not be limited to, the following: Offenses-Miscellaneous 12-4 (a) The sound level of the objectionable noise; (b) The sound level of the ambient noise; (c) The proximity of the noise to residential sleeping facilities; (d) The nature and zoning of the area from which the noise emanates; (e) The density of the inhabitation of the area from which the noise emanates; (f) The time day or night the noise occurs; (g) The duration of the noise and its tonal content; (h) Whether the noise is continuous, recurrent or intermittent; (i) Whether the noise is produced by a commercial or non-commercial activity; (j) The intensity of the noise; (k) Whether the noise is natural or unnatural; (l) Whether the noise is usual or unusual. (Ord. No. 512 N.S., 12/89)

9. 12.8.2 Prohibited Noise. In addition to the prohibition described in paragraph 12.8.1, the following noise is specifically prohibited: (a) Construction and Demolition. Operating or causing the operation of any tools or equipment used in construction, drilling, repair, alteration or demolition activities between the hours of 6:00 p.m. and 8:00 a.m. each day, Sunday evening through Saturday morning, and between the hours of 6:00 p.m. and 9:00 a.m. Saturday evening through Sunday morning. (b) Gasoline-Powered Blower. It shall be unlawful for any person to operate a gasoline-powered device used to blow leaves, dirt or other debris off sidewalks, driveways, lawns or other surfaces within any area of the City except that gasoline-powered leaf blowers may be used by public agencies on publicly-owned or operated facilities. (Ord. No. 517 N.S., 3/90)

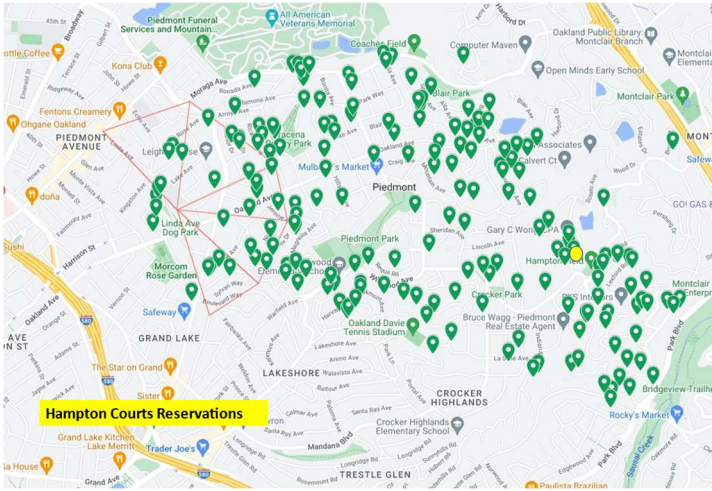
10. 12.8.3 Exceptions

11. (a) Emergency Repairs. Emergency work conducted by public service utilities or governmental agencies shall be exempt from the provisions of this ordinance; provided that in the case of such emergency work, the public service utilities or government agencies involved shall promptly contact the Piedmont Police Department prior to or within 30 minutes after commencing such emergency Offenses-Miscellaneous 12-5 work, providing the Police Department with the exact location of the work, the time anticipated to complete the work, the nature of the work to be performed, and whether any assistance from the Police Department or other City services are anticipated in connection with such emergency work.

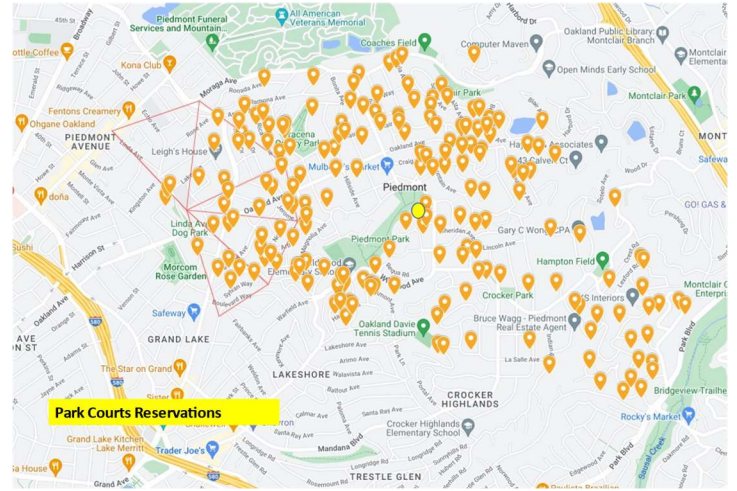
12. (b) Other. The City Administrator may grant temporary written exceptions to the Noise Ordinance upon the showing of good cause by the applicant. (Ord. No. 512 N.S., 12/89) 12.8.4 Violations. Violation of any provision of the Noise Ordinance shall be an infraction. The City Council shall set the fine for violations from time to time by resolution. (Ord. No. 512 N.S., 12/89)

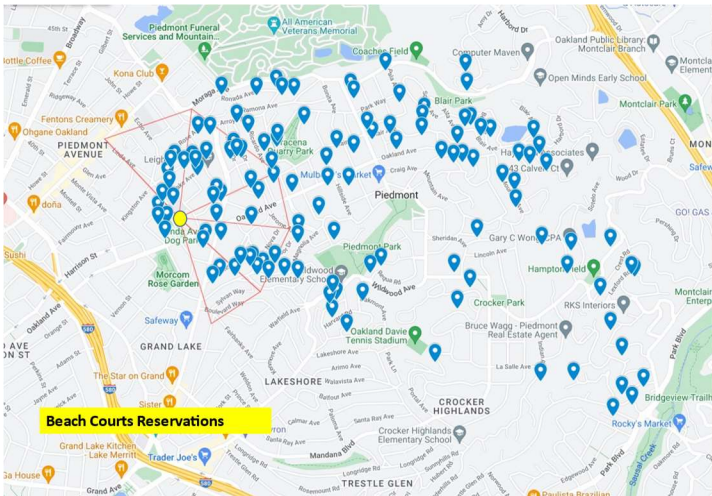
Decal location reservations at Hampton Courts in 2022
